Death

22. How has Scout's relationship with Boo Radley changed?

In a way they are Boo's children too now because he saved them

23. Discuss the controversy over how Mr. Ewell died

Atticus thought Jem might have done it, he wanted Jem to live without having a lie over his shoulders

Sheriff Tate said he fell accidentally on the knife and it was self-inflicted... Atticus thought Heck was trying to protect by he was actually protecting Boo, who killed Mr. Ewell. Scout understands this cover up and compares the trial of Boo to shooting a mockingbird (symbolism again)
