Use the poem you choose to answer the <u>one</u> of the questions below. You must answer <u>one</u> of the questions in a well-developed response, using <u>1 vocabulary word from Unit 2</u> (either unit 2A or unit 2B). Be sure to <u>underline the vocabulary word.</u> Incorporate <u>2 textual citations</u> as evidence into your responses. Refer to the Claim, Data, Warrant (Answer Prompt Directly, Cite Evidence and Explain Evidence) and Incorporating Textual Evidence handouts if you need assistance.

Remember:

You must: 1) answer the questions in your own words, 2) incorporate textual evidence to support your response, and 3) explain or elaborate on your textual evidence.

Constructed Response Answers are 5-8 sentences and follow the outline below:

- I. **A**nswer the question directly.
 - A. Cite Text Evidence #1 (internal citation).
 - B. Explain HOW the evidence supports your text evidence.
 - C. **C**ite Text Evidence #2 (internal citation).
 - D. Explain HOW the evidence supports your text evidence.
 - E. Closing/Wrap-Up Sentence

- 2. Which figures of speech—metaphors, similes, idioms—does the writer use? What is the author trying to accomplish by using them? How do they reveal and impact the theme of the text?
- 3. How does the Anne Bradstreet's use of words (diction), imagery, or details reveal her attitude towards her husband in the poem?

- 4. How does the author use conceit to reveal and develop the theme of the poem?
- 5. What words (diction) best describe the author's attitude toward the topic? Why?
- 6. Describe the relationship between the speaker and God. What does the speaker say will make him a complete and fulfilled person?
