### Unit 3 - Bill of Rights/Civil Rights/Civil Liberties

#### **Unit Overview**

This unit focuses first on an analysis of the first ten amendments, known as the Bill of Rights, to gain an understanding of how each of these rights are secured. Then, the focus shifts to defining civil liberties and civil rights, analyzing due process of law as expressed in the 5th and 14th amendments, and explaining how amendments extended the right to vote.



- 1. Congress can't deny your right to due process, property, not incriminate yourself, tried for the same crime twice, etc.
- 2. Reserved rights
- 3. In all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial, by an impartial jury, with the right to hear the accusations against him and confront witnesses.
- 4. "Extra rights"
- 5. No cruel and unusual punishment or excessive fines and bail.
- 6. No search without a warrant based on probable cause
- 7. Protects the freedom of religion, assembly, petition, press, and speech
- 8. Protects the right to bear arms
- 9. Right of the accused to a jury trial.
- 10. Troops can't be quartered in your home without the homeowner's consent
