WHEREAS, School Board and Tech Advanced will enter into a School Board Agreement ("Agreement") dated January 1, 2021, pursuant to which Tech Advanced agreed to provide the School Board certain computer and peripheral repair services.

Tech Advance will affirm commitment to reimbursing the District for a minimum of one (1) Zendesk license (approximately \$44.00 per month) to be maintained during the entire award Term and subsequent renewals, as applicable.

All other terms and conditions of the Agreement shall remain in full force and effect.
