Salmon River Electric Cooperative belongs to the Idaho Consumer Owned Utilities Association (ICUA) who sponsors a week long, fun filled motivational seminar focusing on leadership and team building. Selected students who attend will learn about cooperatives and the electrical business and build lifelong friendships in the process! They will meet students from Alaska, Wyoming, Oregon, Nevada, Washington and Idaho. High school sophomores and juniors whose parents or guardians are served power from SREC are eligible to apply.

SREC is offering three **\$500** scholarships to the current sophomore or junior students who are selected to attend the youth rally. The scholarship funds will be held by SREC until proof of enrollment at an accredited university or technical program has been furnished by the student to SREC. The scholarship funds will then be paid directly to the university. In addition to the scholarship awarded by SREC, multiple \$1000, \$500 and \$300 scholarships are awarded at the youth rally. Scholarships are awarded at the rally based on interviews, participation, and attitude. It will also be viewed favorably on local SREC scholarship applications if the candidate has attended the ICUA Youth Rally.

Youth attending will also have the opportunity to interview for a chance to represent the state of Idaho in Washington DC. One lucky applicant will be chosen to return in 2025 to attend a weeklong conference in Washington DC with fellow students from around the nation.

The Youth Rally will be held July 8<sup>th</sup> -13<sup>th</sup> at the Northwest Nazarene University in Nampa, Idaho. Transportation and all expenses are paid by Salmon River Electric.

All applications must be submitted on or before April 11, 2024. Selection will be determined based on the application below.
