<u>Call to Order</u> – Superintendent Sullivan called the meeting to order at 4:00 p.m.

Meeting Norms – The meeting norms were available for review on the agenda.

<u>Additions or Deletions to the Agenda</u> – There were no requests for additions or deletions to the agenda.

<u>Review and Approve the March 7, 2018, Meeting Minutes</u> – Mrs. Fisher moved to approve the March 7, 2018, meeting minutes, as presented. Mrs. Streeter seconded the motion. The motion carried unanimously.

AdvancED Engagement Review (November 4-7, 2018) -

System Quality Factors Diagnostic — Superintendent Sullivan noted at the last meeting, the team had broken up into groups and they reviewed Groups A-C of the System Quality Factors Diagnostic. Dr. Sullivan asked the team to again break up into groups and review Groups D, E, and F of the System Quality Factors. Superintendent Sullivan said he would make the edits and email the revised version. He reminded the building principals they needed to complete the school quality factors diagnostics and work with their faculty and staff on their documentation.
