Review Math Adoption Process and FAQs	Q: How much of the work are students doing on the computer? How much creative thinking are they doing instead of plugging and playing?  A: Variety of screen, workbook, and hands-on based on the observation.  Group discussion and online learning.  Q: When we went to one of the classroom visits piloting iReady, it was their first-week piloting. It would be nice to see what the outcome was and how the teachers felt about it.  A: We will ask the math adoption team to bring back educator survey feedback now that the pilot has come to an end.  Q: Are the hands-on materials translated into Spanish? And the teaching materials?  A: The hands on materials are translated, not all the teaching materials for all the pilots are translated in Spanish.  Q: Will student feedback be presented?  A: I believe so, we will ask the math adoption team to include the feedback in the February presentation.	The final presentation and CCAC recommendation will be at our next CCAC Meeting on February 3rd, 2025.

## From Oregon Department of Justice:

D. Requirements of the Law; 7. Minutes and Recordkeeping:

"The written minutes or recording must include at least the following information:

- members present;
- motions, proposals, resolutions, orders, ordinances and measures proposed and their disposition;
- results of all votes; and, the vote of each member by name, except for public bodies consisting of more than
   25 members unless recording by name is requested by a member of that body;
- the substance of any discussion on any matter; and
- a reference to any document discussed at the meeting, unless even a reference to the document is exempt under Public Records Law.

Written minutes need not be a verbatim transcript, and a sound, video, or digital recording is not required to contain a full recording of the meeting, except as otherwise provided by law. However, the minutes or recording must contain the above information and must give "a true reflection of the matters discussed at the meeting and the views of the participants."
