



Treasurer Report: Nov 26, 2022

2023 Budget Highlights:

- Budget has a short fall of approximately \$17k
 - This is approximately \$6k more than 2022 due to unknown cost related to the winter invitational –
 Judge and MEPA sponsorship fee. Cost was paid in prior years except 2021 and 2022. Unsure whether
 to expect the cost again.
- · Need to work this year on either increasing revenue or reducing cost for the boosters to stay sustainable
- Largely due to booster need to support staff cost, approximately \$47K in cost will be paid in 2023 that will need
 to be reimbursed from school account.
 - o Marching band \$20k
 - o Middle school Guard \$11,570.47
 - o IPE \$9,250
 - o Little Belles \$3,175
 - o Open guard \$2,531
