Student Summer IT Help Report

Mr. King highlighted the students and their accomplishments over the summer to help the IT department get ready for the upcoming school year.

Superintendent Report

Superintendent Hamilton highlighted the events, summer programs, camps and activities that took place over the summer.

The John F. Kennedy Elementary School held a kindergarten Meet and Greets in July and August. Classroom assignments for homerooms were sent out in early August. Bulldog Academy was held for grades 1-5. Special Education summer school was held between July and August and many back to school events have started to take place.

New student orientation took place this past week in the auditorium. The Holbrook Middle-High School had Bulldog Academy for multi-lingual learners and 6th grade move up day took place.

In district-wide news the leadership team went on a retreat where they took a look at the new teacher evaluation rubric. They also had a legal update workshop with the school attorney. Our new district student opportunity act plan was approved by the department of education. The district will be implementing a tool called Talking Points to ensure that our parents and guardians feel that we are accessible beyond the email and connected.

Superintendent's Goals Update

Superintendent Hamilton presented an overview of her goals and the progress she has made towards them. These goals were developed in the late spring/summer 2024 and are aligned to the new HPS multi-year strategic plan. Formative assessment by the school committee will occur by August 2024, while a summative evaluation will be conducted by August 2026.

Goal 2: To work with DESE, the South Shore Early College Consortium, guidance counselors and building staff to continue expanding college and career pathways for the students of the HPS which aligns with HPS Strategic Goal I.

Goal 3: To collect data from multiple sources to inform and drive long-term facilities planning which aligns with HPS Strategic Plan Goal IV.

Goal 4: To work with building administrators and staff to implement effective instructional practices that will strengthen Tier 1 instruction across PK-12 which aligns with HPS Strategic Goal 1).
