i. Discussion of the DCPS Cell Phone-Free Education DRAFT Policy

(This is an informational/discussion agenda item for the School Board)

Background: On Thursday, July 9, 2024, Governor Youngkin issued Executive Order #33: Establishing Cell Phone Free Education to Promote the Health and Safety of Virginia's K - 12 Students.

On Tuesday, September 17, 2024, the final guidance document was released from the VDOE recommending "bell-to-bell cell phone free education. The final guidance document defines cell phone-free education in Virginia's schools as "bell-to-bell", meaning phones should be turned off and stored away from the first bell at the start of the school day to begin instructional time until the dismissal bell rings at the end of the academic school day. "Bell-to-bell" includes lunch and time in between class periods.

DCPS has determined "bell-to-bell" from 8:00 a.m. to 3:00 p.m.

The guidance addresses students not having their cell phones "on their person" during the bell-to-bell school day, including not in their pockets. Cell phones and personal electronic devices will be stored in their lockers.

Process Followed:

- On Thursday, Oct. 10, 2024, Central Office Directors and administrative staff met to discuss the DRAFT policy and provided significant feedback and input on the policy. Although the draft policy came primarily from the Guidance Document, the administrative staff provided insight and directions as to implementation and disciplinary actions.
- The DRAFT policy was then revised to include the recommendations from the administrative staff, and emailed to all staff members.
- On Oct. 17, 2024, a survey was distributed to all staff members requesting their input and feedback.
- The DRAFT policy presented to you includes suggestions and recommendations from staff input on staff surveys.
