BID FOR: Facility Condition Assessment RFP

SOLICITATION NUMBER: 16-1713

- 1. Can a basic guideline or a project list of current and anticipated Technology be provided?
  - a. The Master Plan section 4B provides a brief overview of the Technology equipment inventory. Section 6B shows the 2015 approved Five Year Technology Capital Improvements Plan. Both sections can be found at <a href="http://www.rock-hill.k12.sc.us/Page/4085">http://www.rock-hill.k12.sc.us/Page/4085</a> As a basic guideline, technology equipment consisting of the Local Area Network (LAN), Television and Audio-Visual Systems including interactive white boards, computer devices and peripherals, office machines and telephone systems will not be assessed under this contract. Public Address, Intercomm, Fire Alarm and Security (intrusion detection) Systems will be assessed. Each school campus to be assessed has all of these systems installed. These systems are undergoing major repair and replacement under current capital outlay programs. See also attached revision of Attachment 4, Facilities Systems Inspection for further details.
- 2. What is the actual square footage being assessed?
  - a. The requested square footage to assess is calculated at 3,256,450 SF. This amount is the SF listed in Attachment 2, less the excluded sites shown in the attached revised Attachment 1, less mobile classrooms and other temporary structures excluded from the assessment. This amount should be considered accurate for proposal purposes. An inventory reconciliation was performed in 2012 and results will be provided to the consultant for verification as part of this contract.
- 3. The RFP mentions that 85% of the buildings are digitized. It has been mentioned the proposal is to include documenting and drafting the remaining 15%, is this correct and to please clarify the level of the drafting product (ie: architectural floor plans only, or are elevations, MEP/FP plans, etc. and are they to be "smart" plans)? Also, does the 85% refer to the number of structures or the gross square feet of buildings?
  - a. There is approximately 300,000 sf not digital, the 85% refers to floor plans only gross sf.

- 4. Since some facilities are not included within the scope and the noted total square footage of 3,446,777 includes all district structures, will RHSD provide a revised sf amount of only facilities to be included?
  - a. See addenda 1
- 5. Would you define the "Choice" program requirements?
  - a. The district currently offers school choice in seven distinct programs. One or more of these programs is currently offered at nine of our school sites. Specific listings are found at <a href="http://www.rock-hill.k12.sc.us/Page/5064">http://www.rock-hill.k12.sc.us/Page/5064</a>
    These schools are currently undergoing modernization of varying degrees as part of the district's Choice Program Improvement Plan. Beyond these "upfits", we anticipate few infrastructure requirements that are particular to a choice program. The biggest impact for this assessment is likely to be consideration for functional program assignments for certain rooms in a school, such as a dance or drama room at a School of the Arts, a "maker space" for a STEAM school, etc. These program assignments will vary by school and are fluid at this time due to the Improvement Plan work. The district will provide specific guidance to the consultant prior to commencement of work.
- 6. Are topographic surveys with underground utilities noted required for each of the 32 sites?
  - a. They are not required but can be included as an alternate line item on the bid form.
- 7. Which buildings have vertical transport of all kinds (elevators, dumbwaiters, wheelchair lifts, etc.) and how many levels at each?
  - a. Northside 1 Rawlinson 1 Sullivan 1 Northwestern 2 Rock Hill 3 South Pointe 3 Flex Center 1 all are 2 levels
