

SAU 19 New Boston School District and Goffstown School District Google Apps for Education Parent Permission Form

Dear Parents/Guardians,

Goffstown and New Boston students in Grades 3-12, teachers and staff utilize Google Drive and Google Docs for education. Through Google Drive, students are able to collaborate with teachers and other students on educational assignments. This permission form describes the tools and student responsibilities for using these services. We believe that a strong partnership with families is essential for the success of all teaching and learning experiences.

The following services are provided in Google Apps for Education (GAFE):

- **Calendar** – a student calendar providing the ability to organize schedules, daily activities and assignments
- **Docs** - Word processing, spreadsheet, drawing, and presentation tools similar to Microsoft Office
- **Desktop publishing** - Lucid Chart and Lucid Press
- **GMail** – email service is not available to students

These services are hosted by Google on their servers and are available at any time from any Internet enabled device. Some examples of student use could include individual assignments, class projects, electronic portfolios and working in groups on presentations to share with others. *Technology use in the Goffstown and New Boston School Districts
is governed by state and federal laws including, but not limited to:*

Children's Online Privacy Protection Act (COPPA) COPPA applies to commercial companies and limits their ability to collect personal information from children under 13. This permission form allows the school to act as an agent for parents in the collection of information within the school context. The school's use of student information is solely for education purposes.

Family Educational Rights and Privacy Act (FERPA) FERPA protects the privacy of student education records and gives parents the rights to review student records. Signing this form acknowledges that some student records, such as portfolios of student work with teacher feedback, may be stored in a student's GAFE accounts on Google servers.

Guidelines for Use of SAU 19 Google Apps for Education by Students

All Goffstown and New Boston School Board Policies, including the Districts' Acceptable Use Policies (Goffstown School Board Policies GBEF and JICL and New Boston School Board Policies GBEF and JICL), apply at all times to the use of District provided GAFE accounts. All access to Google Drive will occur through SAU created accounts. These accounts will be used for school related work and projects only. **No student will be assigned the use of an account without prior parent or guardian permission.** Once permission is confirmed, students will receive instruction on how to access the wealth of collaborative tools available through Google Docs.

The Goffstown and New Boston School Districts cannot and do not guarantee the security of electronic files located on Google systems. Although Google does have privacy controls, the Districts cannot assure that users will not be exposed to unsolicited information.

The general right of privacy will be extended to the extent possible in the electronic environment. The Goffstown and New Boston School District users and all electronic users should treat electronically stored information in individuals' files as confidential and private. Users of student accounts are prohibited from accessing files and information other than their own. The District reserves the right to access GAFE student account information when deemed appropriate.
