Ms. Straughters stated that throughout the eight-week program, she was very impressed by their display of unity, teamwork, attendance, and good work ethic. The students then shared their thoughts, each stating they felt positively about the experience, having learned a lot through the college course and about themselves.

Professor Fox of CCAC was the instructor for the English 101 course. She feels the students were very motivated. Even when faced with a couple of frustrating moments, the group worked through it together, encouraging one another to continue. Of note is that even though this course was only eight weeks, it was actually the equivalent of a sixteen week course.

Mr. Herzing refers to these students as "academic leaders." Mr. Dalmas and the Sto-Rox School Board are very proud. In addition to earning three credits toward college, this summer spent at CCAC certainly helped them learn valuable social and emotional skills like learning from their mistakes, mentoring, interacting with new people, accepting others, and taking on responsibility. We know they will continue to work hard toward success in their academic and career goals!
