SAGE Academy Enrollment Process: Terms and Conditions

Application Information

• This application form is for current 3rd and 4th grade out of district students and students that reside in the 719 district boundaries, but do not currently attend Prior Lake-Savage Area Schools. All current ISD 719 second grade students are automatically screened for entry into SAGE Academy. Parents of ISD 719 students in grades 3 and 4 who meet the MAP requirements can request a reevaluation for their child by filling out the Application, CogAT Registration Form and contacting Karen Zwolenski, SAGE Academy Coordinator at 952-226-0400 or by email at kzwolenski@priorlake-savage.k12.mn.us. Non-district residents are also required to fill out the Application, register for CogAT testing (testing fee applies) if necessary and contact Mrs. Zwolenski.

Transportation

• Transportation is provided to SAGE Academy students if they live within the Prior Lake-Savage Area School boundaries. Families living outside of the district must provide their own transportation.

Siblings

• Siblings of SAGE Academy students may attend WestWood Elementary through open enrollment or indistrict transfer when space is available in the receiving grade level.

Attendance Information

- District/Out of District students who are eligible to attend SAGE Academy will be notified by February 25, 2019.
- Once a student qualifies for SAGE Academy, he/she will remain in the program and does not need to reapply for subsequent years.

Placement Information

- All eligible students from within the district will be given first preference for SAGE Academy.
- Candidates who are non-district residents and meet criteria are placed next. Assessment will be required and paid for by non-district resident applicants.

All eligible students from within and outside of the district were offered placement in the 2018-19 classes.
