Please provide a brief explanation of why the 2017-18 and 2018-19 school year participation rates were below 95%. (250 words or less)

In the 2017-18 school year, 96 students refused (opted out) of the ELA assessment and 95 students refused (opted out) of the Mathematics assessment. These refusals (opt-outs) had an impact on Moriches Elementary School's participation rate.

In addition, the average daily attendance for the 2017-2018 school year was below 95% at 93.70%. The average daily attendance was 94.65% for the day of the ELA assessment. Although the average daily attendance was 95.59% for the Mathematics assessment, the number of student refusals (opt-outs) impacted the participation rate on this day.

In the 2018-2019 school year, Moriches Elementary saw an increase in the number of refusals (opt-outs) with 142 students refusing (opting out) of the ELA assessment and 154 students refusing (opting out) of the Mathematics assessment.

Again, the average daily attendance was below 95% at 92.87% for the 2018-2019 school year. The average daily attendance was 93.93% for the ELA assessment and 93.70% for the Mathematics assessment.

| <p>Provide a brief description of the Consultation and Collaboration process for development of the plan.</p> | <p>In anticipation of needing to develop a plan, district administration and faculty began meeting in the 2018-2019 school year as well as this current year, 2019-2020.</p> <p>We met to develop a communication plan for parents to emphasize the importance of taking the state assessments and to build their knowledge of ESSA. 


| Describe the chosen strategies and key activities to be implemented to improve Participation Rate. | <p>William Floyd School District and Moriches Elementary School implemented several strategies to improve the participation rate for the 2019-2020 school year.</p> <ul style="list-style-type: none"> • District and building level PTO meetings in addition to Parent-Teacher conferences were utilized to share information regarding ESSA and the state assessments. Parents are encouraged to ask questions during these meetings to deepen their understanding. These meetings help to support parents in developing an awareness of the value of assessments. This awareness leads parents to make a more informed decision related to their child participating in the assessments. In addition, these meetings often help break the pattern of refusing (opting out) every year because the parents become more informed about ESSA and the assessments each passing year. • The William Floyd School District has a new user friendly website where parents can quickly obtain information. Our Public Relations Director and our District Technology team consistently update the information on the website to provide parents with quick access to announcements. Pop-up boxes of important information are displayed on the website and social media vehicles such as Facebook and Twitter are used to convey information about state assessment dates. Moriches administrators and teachers may use the Remind app to remind parents of upcoming state assessment days. Finally, all state assessment dates are printed on our district calendar which is mailed to each home during the summer as well as provided to all new entrants who register in the district. • District Office administrators and Moriches administrators meet with teachers on a regular basis to provide training and information as it relates to ESSA and state assessments. As evidenced in the description of Consultation and Collaboration above, these meetings were essential |

| | <p>as we anticipated the need to develop a plan to increase our participation rate.</p> <ul style="list-style-type: none"> Attendance programs and interventions to raise student attendance have been implemented in an effort to increase attendance on a daily basis and on test taking days. Moriches added an advisory period built into each day which provides additional academic support and special activities. Students are motivated to attend school and arrive on time in order to take advantage of this period. The district has revised attendance codes and trained the attendance aides in all buildings to ensure consistency throughout the district. In turn, we are able to collect accurate data on student attendance and identify patterns in absences. Chronic absence post cards and letters are mailed home to alert parents to the attendance concern and encourage the parent to collaborate with building staff to improve the child's attendance. These letters are also available in Spanish to ensure all families have access to their child's attendance information. The Director of Student Services gave a presentation on ENL Parent Night to share strategies to increase student attendance. The Director of Student Services also investigates possible residency issues to determine if students are absent due to transportation related concerns and addresses the issue accordingly. <p>There has been a shift in perception regarding these state assessments due to the diligent work of administrators and teachers at Moriches Elementary. Students are less likely to refuse (opt-out) as their parents are better informed about these assessments, thereby resulting in the shift of perception. This is due to increased communication with parents and faculty.</p> <p>We believe that our refusal (opt-out) rates would have decreased this year due to our interventions. Unfortunately, due to COVID19 and our school closure, we will not see the results of our plan this year.</p> |
