Celebration of Excellence

Excellence In Acadmeics

- Second Grade Hero Story Bower Hill 2nd Graders in Mrs. Willkomm's class read the book Fireboat by Maira Kalman this week. It is the inspiring true story of John J. Harvey—a retired New York City fireboat reinstated on September 11, 2001. The story focuses on the everyday heroes of the events on 9/11. Following the story, the students made flags honoring what a hero means to them.
- ➤ Third Grade Math Investigations PV 3rd graders in Mrs. Williams' class did some investigating to wrap up their review of place values! Students arrived in class to find that the Petrifying Place Value Gang was on the loose. The gang left number messes all over the classroom, but our hard working students followed the clues and solved the mystery!
- ➤ 9/11 Reflective Art Project Mrs. DeSalvo's 5th grade students created reflective artwork this month to honor the heroes of 9/11. After learning about the events of September 11th, the students wrote about the effect of the day on the American people and then created artwork to honor the heroes of that day.

Schools are ranked based on their performance on state-required tests, graduation rates and how well they prepare students for college. PTHS is also ranked 7th in Pennsylvania and 312th in the Nation according to the report.
- National Merit Semi-Finalists Five students from Peters Township High School have been named semifinalists in the annual National Merit Scholarship Program. The 16,000 semifinalists nationwide represent less than 1 percent of U.S. high school seniors and includes the highest-scoring students in each state. Seniors Damien Busche, Zachary Byers, Cassidy Griffith, Sydney Shock, and Margaret Stech will now have an opportunity to continue in the competition for National Merit Scholarships, worth more than \$30 million.
