The Regular Meeting of the Central Cass School Board was held Monday, June 12, 2023, at 6:00 p.m. in The District Conference Room. The meeting was called to order by President Brandy Sprunk. Joe Morken moved, Jayme Steig seconded to approve the agenda as presented. Assuming a roll call vote, all members voted "Yes." Motion carried.

Dale Muchow moved, Jayme Steig seconded to approve teaching contracts for Ellie Guy and Jacob Hanson for the 2023-2024 school year, as presented. Assuming a roll call vote, all members voted "Yes." Motion carried.

Joe Morken moved, Dale Muchow seconded to approve the 2023-2024 Consolidated Application for Title I, Title II, Title III, and Title IV, as presented. Assuming a roll call vote, all members voted "Yes." Motion carried.
