- Each STAR Test is to establish a starting point for each student. The results of these
 tests are used to provide data for teachers to supply additional resources. These
 resources can range from interventions in receiving more individual instruction to
 supplying certain students to further excel in the subject being tested.
- ACCESS for ELL students is used to measure progress towards meeting the WIDA English Language Development Standards.
- The MCA/MTAS are used to measure student progress toward Minnesota's academic standards and meet the requirements of the federal Elementary and Secondary Education Act (ESEA). Source of Requirement: <u>Minnesota Statutes</u>, <u>section 120B.30</u> and <u>ESSA</u>.
- All data is also used to enhance instruction to focus on places where they see deficiencies in student results.

- All data is placed into Viewpoint for teachers to access and discuss any needs that become evident through each assessment. Team Meetings and PLC's are utilized to view data and create a plan for instruction.
- Individual MCA results will be shared with family members during fall conferences.
- MCA school and district results can be viewed using the <u>Minnesota Report Card</u> section of the MDE website.
- ACT results will be available to the students 6-8 weeks after testing via ACT account.
- AP European History results will be released in early July via CollegeBoard website.
