- If the student is walking or being driven to Lochburn Middle School they may leave Harrison Prep for practice no later than **3:15 pm** and for games/matches as appropriate. **They MAY NOT arrive at the school where they will participate before 3:30 pm.** Students participating at Hudtloff or Thomas are responsible for arranging their own transportation to practice. They also may not arrive before 3:30.

From 2:10 to 3:15 p.m. Lochburn Middle School Students will have the option to participate in an athletic study hall or our HPX After School program which is held after school on Mondays, Tuesdays and Thursdays. On Wednesdays & Fridays, athletes will gather in the gym to wait until it is time to leave. At 3:15 all students attending the Study Hall/HPX will be released to walk over to Lochburn (with parent permission).

The student must **ALWAYS** sign out in front office before leaving Harrison Prep for games/matches. Parents **MUST** provide transportation for their student athletes to Hudtloff & Thomas **OR** indicate below that the student has permission to walk himself or herself to Lochburn.
