Thank you for your interest in the North Reading Public Schools Integrated Pre-Kindergarten Program. The North Reading Public Schools Integrated Pre-Kindergarten Program is an early childhood program for children ages 3-5 years old, both with and without disabilities. Integrated Pre-Kindergarten programs are required to adhere to specific student ratios to ensure compliance with Early Childhood Special Education (ECSE) regulations. ECSE services are designed for young children (aged 3-5) with disabilities who need specially designed instruction or related services and whose disability(ies) causes the children to be unable to participate in developmentally appropriate typical preschool activities. School districts are required by law to ensure that developmentally appropriate ESCE programs and services are available. An integral part of our Integrated Pre-Kindergarten Program are peer partners, and as such, we look forward to the registration process each year in January. The goal of our Integrated Pre-Kindergarten Program is to promote the social, emotional, physical, and cognitive development of all students. Please find registration documents for the 2024-25 school year included in this packet. All registration documents must be returned to the Office of Student Services by 3 pm on Friday January 19th. If there are more registrants than openings, all registrants will be entered into a lottery. Registration notification will be provided by January 31, 2024.

The Full Day program tuition is \$6,000\*. A tuition deposit of \$200 is due at the time of registration. The remaining \$5,800 is divided into four equal payments of \$1,450.00 due June 1, September 1, December 1, 2024 and March 1, 2025.
