#### **Overview**

The development and biannual progress review of School Improvement Plans (SIPs) are required by the Washington State Every Student Succeeds Act (A.1[viii][d] and [e]) for schools identified for supports under Tier 2, Tier 3, and Tier 3 Plus. OSPI conducts progress monitoring reviews for schools identified as eligible for Tier 3 and Tier 3 Plus supports (i.e., comprehensive, and comprehensive graduation rate, compounded, comprehensive plus, comprehensive graduation rate plus). Local Education Agencies (LEAs, i.e., districts) are charged with progress monitoring for Tier 2 supports (i.e., targeted 3+ and EL progress).

The goal of this rubric and feedback template is to analyze and provide meaningful feedback on the progress schools have made in working toward their goals during the 2023-2024 school year as detailed in Sections I (b) and III of their EOYRs. EOYRs for 2023-24 are due on June 28, 2024.

For Tier 3 and Tier 3 Plus schools not exiting OSPI/OSSI progress monitoring, a completed SIP for school year 2024-2025 will also need to be uploaded to Basecamp by August 30th, 2024.

All OSPI completed EOYR feedback for Tier 3 and Tier 3 Plus schools will be uploaded to appropriate schools' OSPI SharePoint folders and will be emailed to building leadership teams.

This downloadable copy of the End-of-Year Review is for use by ESDs/LEAs in reviewing Tier 2 SIP submissions.
