The state instrument for the identification of ELs is the WIDA Screener. The identification and the subsequent placement of ELs in English as a Second Language (ESL) services are guided at the state level by the North Carolina Department of Public Instruction (NCDPI) Office of Academic Standards. All students identified as ELs (based solely upon the WIDA Screener or ACCESS for ELLs scores) must be administered the ACCESS for ELLs or its alternate during the annual English language proficiency testing window.
