1. **Purpose:**

The funding in this proviso is passed through directly to Northwest Education Access (NWEA) [formerly Seattle Education Access] in order to provide comprehensive and individualized support to assist traditionally underrepresented students to build their own path to higher education and beyond. NWEA is a nonprofit organization serving youth in Pierce and Snohomish counties.

2. **Description of services provided:**

Built and maintained 15 partnerships in Pierce County and Snohomish County collectively with community and technical colleges and community-based organizations, both for referrals and resource mapping.

Met with partners to establish access points for youth reengaging in education to access services, including specific referral requirements, timelines for accessing education programming, and supplemental support programming

3. **Criteria for receiving services and/or grants:**

- Serve at least 825 students each year
- At least 60% of college prep students will either complete their high school credential or take a college entrance exam
- At least 65% of post-secondary students will remain enrolled year to year

ESSB 5693, Sec. 522(18) - \$500,000 of the general fund—state appropriation for fiscal year 2022 and \$500,000 of the general fund—state appropriation for fiscal year 2023 are provided solely for the office of the superintendent of public instruction to contract with a nonprofit organization serving opportunity youth in Pierce, King and Snohomish counties. The organization must assist traditionally underrepresented students on nontraditional educational pathways by providing mentorship and technical assistance in navigating higher education and financial aid. The office may require the recipient of these funds to report the impacts of the efforts in alignment with the measures of the Washington school improvement framework.
