Approve the following Fairborn High School Final Exam Exemption Guidelines and Criteria 2019-20.

- **Exam exemptions are only applicable on final exams in a year-long class. There are no exam exemptions for semester classes or semester exams.**
- **Students will be exempted from taking a final exam should they earn Straights A's for the year in the class, defined as an A in quarters 1, 2, and 3 as well as an A on the quarter 4 interim report.**
- **On the report card, the final exam grade will be left blank with a comment stating there was an exemption. The final grade for the class will be calculated using the remaining factors, the four quarterly grades and the semester exam grade.**
- **Students have the option of taking the final exam for credit, even if they have fulfilled the exam exemption guidelines.**

(Exam Exemption Guidelines and Criteria-cont'd)

- Teachers may not deny exam exemptions for classroom discipline reasons. Teachers may not approve exam exemptions as a classroom reward.
