Goal 1: Revise goal one to include sex education curriculum at the secondary levels in particular, and to look at collaborating with the community for equity and diversity learning opportunities for our staff and students. Mrs. Sicher and Stacy have attended

the "All Things Diversity" in Hershey. Goal 2: Maintain Full Day Kindergarten oversight, this is a three-year goal. This will continue 2020-2021 school year. Goal 3: Charging the district to examine grading practices and reporting at Hershey High School during the school year. We suggest to extend this goal for another year, due to being a roll out implementation with the report card and transcript. Keep and rewrite this goal to extend into the 2019-2020 school year to ensure full freshman implementation. Some discussion was made to possibly "add-on" more sub items to Goal 3 . (ex. internships for all students) Trisha Steiner shared with the Council notes she took while attending a conference at the National School Board Association in Philadelphia. The keynote speaker was the President and CEO of the Society for Human Resource Management. He noted that what hard skills are needed and lacking in the workforce now, and soft skills and that creativity, agility and adaptability are more important than degrees. The hard skills needed are writing, problemsolving, technology, and public speaking. Soft skills are dependability and reliability, adaptability in training, decision making, customer focus, and team work. Mr. Smith spoke to inform the council that the High School coop education teacher, Victoria Smith, is doing a great job. Some of our students are taking

blended classes and are actually doing all these skills. We are up to 800 seats in blended next year.
