Dear Parents/Guardians of Mountain View Middle School 7th grade students:

Newberg School District will be delivering the My Future-My Choice curriculum in the 7th grade in order to align with state requirements. My Future-My Choice is a skills-based, comprehensive, age-appropriate, and medically accurate sexual health education program. My Future-My Choice is designed to help students recognize the pressures and the consequences of early sexual involvement and encourages students to make healthy choices for themselves. Students also learn about puberty, healthy relationships, assertive communication, healthy decision making, and consent.

The Oregon Health Education Standards (revised December 2016) and House Bill 2509 requires age-appropriate, comprehensive sexual health education be taught once a year in middle school. A complete version of Oregon Administrative Rule OAR 581-022-1440 and Oregon Revised Statute ORS 336.455 for comprehensive sexuality education in Oregon public schools, can be accessed at: http://www.ode.state.or.us/search.

Lesson 2: Advantages of Postponing Sexual Involvement - Helps students learn and understand the definition of consensual sexual involvement and the benefits of postponing sexual involvement including achieving personal goals. Lesson 3: Social Pressure - Helps students identify internal and external pressures that could impact their sexual decisions, including media influence. Lesson 4: Peer Pressure - Develop awareness about peer pressure and understand the importance of setting limits. Lesson 5: Learning assertive techniques Learn assertive techniques to resist pressure to become sexually involved before young people are ready. Lesson 6: Changes Understand the stages of puberty for both males and females, and the related vocabulary. Lesson 7: Recognizing the risks Recognize the possible short- and long-term consequences of becoming sexually active at a young age. Identify methods of protection including abstinence, disease reduction measures and contraception. Lesson 8: Communication and refusal skills Understand the importance of effective communication and practice communication skills to refuse pressure. Lesson 9: Taking responsibility Recognize healthy and unhealthy traits in a relationship and the responsibility for making healthy choices in our relationships. Lesson 10: Reinforcing skills Review and reinforce previous learning.
