Minutes School Board Business Meeting Fridley Independent School District 14 September 17, 2013

Call to Order

Gordon Backlund called the Business Meeting of the Fridley School Board to order at 7:30 p.m. on Tuesday, September 17, 2013 in the Fridley City Council Chambers. Present: Gordon Backlund, Fred Bischke, Mary Kay Delvo, Marcia Lindblad, and Kim Sampson. Absent: Chris Riddle.

Approval of Agenda

Motion by Lindblad, seconded by Sampson, to approve the agenda for September 17, 2013. Upon vote being taken, all voted in favor, none voted against, none abstained. Motion carried 5-0.

Superintendent and Staff Reports

- 1. Toni Craft presented a **Year End Report on Community Education**. Community Education programs include Adult Enrichment, Youth Enrichment, Aquatics Programs, Tiger Club Childcare, Early Childhood Family Education, Fridley Infant Toddler Teen program, School Readiness programs, PYP Preschool, Early Childhood Screening, Adult Basic Education, Facility Usage coordination beyond school activities, Fridley Community Theatre, Community Education lifelong learning opportunities, and the Fridley Schools Foundation.
- 2. Jael McLemore presented the **Fridley Public Schools Annual Report to the Community**. The report included district highlights on programs, student accomplishments, staff activities, community partnerships and support, student academic achievement and site academic goals.

Business Action Items

1. RESOLUTION Accepting Gifts

WHEREAS, School Board Policy 706 establishes guidelines for the acceptance of gifts to the District; and

WHEREAS, Minnesota Statute 465.03 states the School Board may accept a gift, grant, or devise of real or personal property only by the adoption of a resolution approved by two-thirds of its members;

THEREFORE, BE IT RESOLVED, that the School Board of Fridley Public Schools accepts with appreciation the following gifts received by the School District:

2. RESOLUTION Appointing Election Judges for the General Election to be Held on November 5, 2013

The School Board is required to appoint election judges for the General Election of the Fridley School Board to be held on November 5, 2013 no later than 25 days prior to the election. Pursuant to the recently approved Joint Powers Agreement, these persons are being hired as employees of Anoka County. After the election the County will submit an invoice to Fridley Schools to cover election costs.

WHEREAS, the Fridley Independent School District will be conducting a General Election on Tuesday, November 5, 2013; and

WHEREAS, pursuant to Minnesota Statutes Section 204B.21, election judges for precincts in a school district election must be appointed by the board of that school district; and

WHEREAS, the persons selected to serve meet all requirements of MN statute and district administrative policy, and have been trained and certified pursuant to law.

NOW THEREFORE, BE IT RESOLVED by the School Board of Fridley Independent School District, State of Minnesota, as follows:

3. RESOLUTION Supporting Race to the Top Application

BE IT RESOLVED by the School Board of Fridley Public Schools District No. 14, State of Minnesota, as follows:

WHEREAS, Fridley Public Schools District No. 14 proposes to join together with South St. Paul School District No. 6 and Minnesota Science Museum Science House in an effort of bold reform and innovation in learning and teaching that will directly improve student achievement and educator effectiveness,

WHEREAS, in order to implement this plan a Race to the Top Grant Application is being submitted to the U. S. Department of Education by this consortium,

THEREFORE, we fully support the Race to the Top Grant Application being submitted by Fridley Public Schools District No. 14, South St. Paul School District No. 6 and Minnesota Science Museum Science House.

5. Second Reading of Policies 509 Enrollment of Non-Resident Students, 515 Protection and Privacy of Student Records, and 532 Use of Peace Officers and Crisis Teams to Remove Students with IEPs from School Grounds

• The purpose of policy 509 Enrollment of Non Resident Students is to set forth the application and exclusion procedures used by the school district in making determination of

- student application eligibility and approval or rejection of applications for enrollment as non-resident students.
- The purpose of policy 515 Protection and Privacy of Student Records is to establish requirements for the protection and privacy of student records.
- The purpose of policy 532 Use of Peace Officers and Crisis Teams to Remove Students with IEPs from School Grounds is to describe the appropriate use of peace officers and crisis teams to remove, if necessary, a student with an individualized education program (IEP) from school grounds.

Motion by Lindblad, seconded by Delvo, to approve and adopt Policies 509 Enrollment of Non-Resident Students, 515 Protection and Privacy of Student Records, and 532 Use of Peace Officers and Crisis Teams to Remove Students with IEPs from School Grounds.
