POSITION: Adult Education Public Safety Coordinator

MINIMUM QUALIFICATIONS: Possess or qualify for a valid Ohio adult educator's license or permit. Must have a minimum of a Bachelor's degree or equivalent. Must possess or qualify for an Ohio Certification as a Firefighter Level II, Paramedic, Fire Instructor, and EMS Instructor.

In the preceding seven years, certified for at least five years as a firefighter. Possess a current and valid Ohio Firefighter certificate. Pass the Ohio instructor knowledge exam at the Firefighter II level within one year prior to admission into fire instructor course. Complete the Ohio fire instructor training course. Successfully pass the Ohio instructional methods exam. Comply with the requirements for an Ohio firefighter certificate. Submit a completed Ohio Fire Instructor, Assistant Fire Instructor, and/or Fire Safety Inspector Initial Application within two years of passing the Ohio Knowledge exam.

In preceding seven years, certified or licensed for at least five years as an EMS provider, registered nurse or physician assistant. Possess a current and valid certificate to practice as an EMS provider or hold a current and valid Ohio license to practice as a registered nurse or physician assistant. Pass the instructor knowledge exam within the preceding three years at the level of the individual's certificate to practice as an EMS provider. Pass the practical exam within the preceding three years at the level of the individual's certificate to practice as an EMS provider. Complete the EMS instructor training program. Pass the instructional methods exam within one year of completion of all the other components of the EMS instructor training program.

Possessing excellent interpersonal, organization, technology, and communication skills are desired traits. A valid Ohio driver's license and positive background checks (BCI/FBI) are mandatory.

GENERAL DESCRIPTION: The coordinator shall provide departmental leadership for the continuous improvement of the adult education public safety service instructional program. The coordinator shall maintain programs in accordance with The Ohio Department of Higher Education, The Ohio Division of EMS, CoAEMSP/CAAHEP and ACCSC accrediting bodies. The instructor shall maintain contact and build positive relationships with industry professionals. The candidate shall implement the Superintendent's directives, district goals, and policies of the Board of Education.
