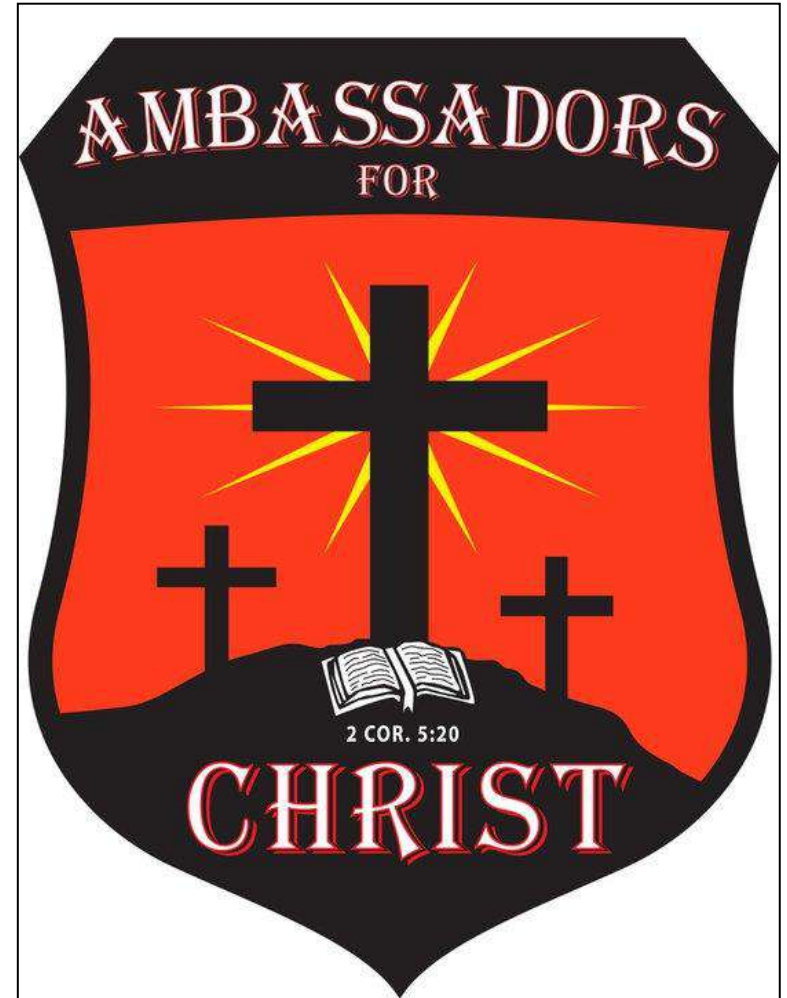

Welcome to Ambassadors for Christ! This afterschool activity for children in grades 1-5 is organized by an advisory board of parents and faculty. It is a non-denominational, Christian organization. This exciting group, in its 24th year, is

led by middle school and/or high school students, most of whom are South Lebanon alumni. Parent volunteers are present to chaperone the group.

Meetings take place after school every first Thursday of the month when school is in session from November through May. Please note that March will have a session on the first and fifth Thursday, since school is not in session the first Thursday of April. Please see the dates on the back of the brochure. The meetings are from 3:45 – 4:30 pm in the South Lebanon Elementary School's LGI Room.

Meetings may include snacks, Bible lessons, songs, prayer, etc. There may also be a few special events such as a Christmas celebration, and a year-end outdoor event, weather permitting.

Our first meeting is scheduled for Thursday, November 3, 2022.

In order for your child to participate, it is essential that you provide written permission using the form in this brochure.

Because this is **NOT** a school-related activity, your child will not be permitted to participate or be excused from his/her classroom to attend without your written signature and emergency information. Please note that transportation must be provided following the meeting by the parent of his/her designee, as indicated on the form. Each meeting will end promptly at 4:30 pm and parents, or their designee, must transport their children immediately following the meeting. Child pick up is at the doors close to the LGI/gym hallway. For added protection of your child, we ask that you sign out your child with the activity leader when you pick him/her up. Also, if your child will not be participating on any given Thursday during the school year, please send a note to your child's regular classroom teacher so notification can be made to the Ambassadors for Christ volunteers.

Using the Remind app is recommended for participating families for communication. A code will be given at the AFC meeting during child pick up.
