VI. SUPERINTENDENT'S REPORT – The Superintendent updated the public on various start-of- the-year programs for staff. She mentioned the accomplishment of two Neptune alumni who created a bionic hand with a 3D printer. She recognized the efforts of administration in the hiring and training of numerous new staff members. Lastly, she read the following clarifying statement regarding the new health and PE curriculum standards:

Unfortunately, there is a great deal of misinformation out there from various groups that are confusing what they are reading on unauthorized websites from what the real standards and subsequent curriculum include. Neither the standards nor the curriculum are indoctrinating children into any way of life, any particular philosophy or politics, advocating sexual activity, or any value system other than safety and inclusivity.

What this means in the health standards in the youngest grades is addressing stereotypes. We teach that the implicit messages that boys and girls receive such as boys do better in math and science and girls in the arts is harmful to children and can prevent them from exploring their passions and talents. In middle school grades, we teach students about the natural feelings they experience as well as the changes their bodies will undergo during puberty. We teach the accurate names for body parts as well and focus too on the need for emotional support during this time. As students move into high school, they need to be aware of their choices as social pressure and the risk of dating violence become more prevalent. These students, too, need to have the language to communicate clearly when they have concerns or at risk.

The standards are comprehensive health and physical education standards and are mandated to be in place by September. The state is not mandating how to teach the standards or the resources we will use. Our curriculum department and health and P.E. teachers will vet all materials, as they always have, before teaching any lesson. Parents have the right in this curriculum, to "opt out" of any particular lesson. Additionally our Curriculum and Instruction Director, Dr. Millaway, has arranged for a parent information session at each elementary school, during the month of October.

President Jackson read the following statement in anticipation of public inquiry: It has come to our attention that members of the community are upset over the reinstatement of Mr. Michael Smurro. The district took legal action to terminate through tenure charges, but the arbitrator assigned to the case instead ruled in favor of a penalty of six months' unpaid suspension. Mr. Smurro's tenure status remains in place and he has been reinstated as a vice principal of safety located in Central Office. This information is available to the public on the Department of Education's website, but because this is a personnel matter, no additional comment will be made.

VII. PUBLIC FORUM - A member of the public raised concerns pertaining to an apparent HIB incident from a prior year and midway through, the Board President cautioned her against identifying students in public. Several members of the public expressed support for the new health curriculum standards. A member of the public commented on what he perceived was a toxic atmosphere among members of the Board of Education. A large group of supporters and members of the LGBTQ community voiced their anger, frustration and disappointment with the outcome of the Smurro decision. They cited statistics of violence against them on a regular basis as well as high rates of suicide among transgender people. They reminded the Board that there is no room for hate in the district and that they will continue to voice their concerns and apply pressure to change the outcome.
