1. FORTINET FIREWALL PURCHASE				
MOVED BY MEMBER, SUPPORTED BY MEMBER, that the Board of Education, at the recommendation of Kim Crenshaw, Executive Director of Curriculum and Technology approve the purchase of new firewall. The firewall is a security device that helps protect the network by acting as an intermediary between the internal network and outside traffic. This purchase will be funded partially through erate funding. The total cost of the project will be \$87,442.23. Erate will pay about half the cost. Our cost will be \$44,407.15. The project was approved by the USAC on July 7, 2022.
