a. Principal's Written Report:

i. School Infrastructure Grant: recommended by commission for full amount \$51,370. They cover 80% we cover 20% (a bit over \$12,000). Window tinting was put into this grant. Next step- will go to Governor's Counsel for approval and we'll be notified in February 2019.

ii. Letter from Bethlehem Reimagined along with a check for \$1000.00 to pay past charges for school lunches up to the end of December 2018 and free meals to all students the week of Dec. 17<sup>th</sup> to 22<sup>nd</sup>. The person wishes to remain anonymous. Principal Roberts fielded questions regarding whether there were funds to pay for families that are paid up but could truly use the support vs people who can afford lunch but have not yet paid.

iii. Meeting with teachers for preschool data collection. 4 are staying and 7 on the wait list for next year.

iv. Questions: 3<sup>rd</sup> and 4<sup>th</sup> grade enrollment – are we considering a combined class? Principal Roberts – have not considered at this time. 20 students for kindergarten next

year at this time. Will not have 2-K, would have a K and K-1, most likely.
