ANY EMPLOYEE OR ANY OFFICIAL OF THE CLAY COUNTY BOARD OF EDUCATION, MANCHESTER, KENTUCKY, ELECTIVE OR APPOINTIVE, WHO SHALL TAKE, RECEIVE, OR OFFER TO TAKE OR RECEIVE, EITHER DIRECTLY OR INDIRECTLY, ANY REBATE, PERCENTAGE OF CONTRACT, MONEY, OR OTHER THINGS OF VALUE, AS AN INDUCEMENT OR INTENDED INDUCEMENT, IN THE PROCUREMENT OF BUSINESS, OR THE GIVING OF BUSINESS, FOR, OR TO, OR FROM, ANY PERSON, PARTNERSHIP, FIRM OR CORPORATION, OFFERING, BIDDING FOR, OR IN OPEN MARKET SEEKING TO MAKE SALES TO THE BOARD OF EDUCATION OF CLAY COUNTY, KENTUCKY, SHALL BE DEEMED GUILTY OF A FELONY AND UPON CONVICTION SUCH PERSON OR PERSONS SHALL BE PUNISHED IN A FINE NOT TO EXCEED FIVE THOUSAND DOLLARS (\$5,000) OR BY IMPRISONMENT IN THE PENITENTIARY FOR NOT LESS THAN ONE (1) YEAR NOR MORE THAN TEN (10) YEARS, OR BOTH SO FINED AND IMPRISONED IN THE DISCRETION OF THE JURY.

EVERY PERSON, FIRM, OR CORPORATION OFFERING TO MAKE, OR PAY, OR GIVE , ANY REBATE, PERCENTAGE OF CONTRACT, MONEY OR ANY OTHER THING OF VALUE, AS AN INDUCEMENT OR INTENDED INDUCEMENT, IN THE PROCUREMENT OF BUSINESS, OR THE GIVING OF BUSINESS, TO ANY EMPLOYEE OR TO ANY OFFICIAL OF THE BOARD OF EDUCATION OF CLAY COUNTY, KENTUCKY, ELECTIVE OR APPOINTIVE, IN HIS EFFORTS TO BID FOR, OR OFFER FOR SALE, OR TO SEEK IN THE OPEN MARKET, SHALL BE DEEMED GUILTY OF A FELONY AND SHALL BE PUNISHED BY A FINE NOT TO EXCEED FIVE THOUSAND (\$5,000) OR BY IMPRISONMENT IN THE PENITENTIARY FOR LESS THAN ONE (1) YEAR NOR MORE THAN TEN (10) YEARS, OR BOTH SO FINED AND IMPRISONED IN THE DISCRETION OF THE JURY.

(1) IT SHALL BE A BREACH OF ETHICAL STANDARDS OF ANY EMPLOYEE WITH PROCUREMENT AUTHORITY TO PARTICIPATE DIRECTLY IN ANY PROCEEDING OR APPLICATION; REQUEST FOR RULING OR OTHER DETERMINATION; CLAIM OR CONTROVERSY; OR OTHER PARTICULAR MATTER PERTAINING TO ANY CONTRACT, OR SUBCONTRACT, AND ANY SOLICITATION OR PROPOSAL THEREFORE, IN WHICH TO HIS KNOWLEDGE;

(A) HE, OR ANY MEMBER OF HIS IMMEDIATE FAMILY HAS A FINANCIAL INTEREST THEREIN; OR

(3) IT IS A BREACH OF ETHICAL STANDARDS FOR ANY PAYMENT, GRATUITY, OR OFFER OF EMPLOYMENT TO BE MADE BY OR ON BEHALF OF A SUBCONTRACTOR UNDER A CONTRACT TO THE PRIME CONTRACTOR OR HIGHER TIER SUBCONTRACTOR OR ANY PERSON ASSOCIATED THEREWITH, AS IN INDUCEMENT FOR THE AWARD OF A SUBCONTRACT OR ORDER.

(4) THE PROHIBITION AGAINST CONFLICTS OF INTEREST AND GRATUITIES AND KICKBACKS SHALL BE CONSPICUOUSLY SET FORTH IN EVERY LOCAL PUBLIC AGENCY WRITTEN CONTRACT AND SOLICITATION THEREFOR.

(5) IT SHALL BE A BREACH OF ETHICAL STANDARDS FOR ANY PUBLIC EMPLOYEE OR FORMER EMPLOYEE KNOWINGLY TO USE CONFIDENTIAL INFORMATION FOR HIS ACTUAL OR ANTICIPATED PERSONAL GAIN, OR THE ACTUAL OR ANTICIPATED PERSONAL GAIN OF ANOTHER PERSON.

GENERAL BID INSTRUCTION AND CONDITIONS

ACCEPTANCE OF BIDS

THE BOARD OF EDUCATION RESERVES THE RIGHT TO ACCEPT ANY BID, TO REJECT ANY OR ALL BIDS, TO WAIVE ANY IRREGULARITIES OR INFORMALITIES IN BIDS RECEIVED WHERE SUCH ACCEPTANCE, REJECTION OR WAIVER IS CONSIDERED TO BE IN ITS BEST INTEREST. THE BOARD OF EDUCATION ALSO RESERVES THE RIGHT TO REJECT ANY BID WHERE EVIDENCE OR INFORMATION SUBMITTED BY THE BIDDER DOES NOT PROVIDE SATISFACTORY PROOF THAT THE BIDDER IS QUALIFIED TO CARRY OUT THE DETAIL OF THE CONTRACT.

BID DOCUMENTS

A BID FORM IS PROVIDED WITH THIS "INVITATION TO BID". ALL PROPOSALS MUST BE SUBMITTED ON THE "BID FORM". THE BIDDER SHOULD MAKE A PHOTOCOPY OF THEIR SUBMISSION FOR THEIR RECORDS.

SPECIFICATIONS

SPECIFICATIONS ARE ATTACHED AND ARE A PART OF THIS PROPOSAL. ALL MATERIAL OR SERVICES FURNISHED MUST BE IN CONFORMITY WITH THE SPECIFICATIONS AND WILL BE SUBJECT TO INSPECTION AND APPROVAL OF THE BOARD OF EDUCATION AFTER DELIVERY. THE RIGHT IS RESERVED TO REJECT AND RETURN AT THE RISK AND EXPENSE OF THE SUPPLIER, ANY ITEM WHICH MAY DEFECTIVE OR FAIL TO COMPLY WITH THESE SPECIFICATIONS.

IT IS IMPORTANT THAT EACH PERSON SUBMITTING A BID FOLLOW CAREFULLY THE SPECIFICATION DETAILED HEREWITH. THE BIDDER IS INSTRUCTED TO COMPLETE ALL BLANKS AND SPACES WHERE INFORMATION CONCERNING ANY ITEM IS REQUESTED. ONLY ITEMS MEETING THE REQUIREMENTS ARE TO BE QUOTED ON THE REGULAR BID FORM.

THE BOARD OF EDUCATION RESERVES THE RIGHT TO WAIVE COMPLIANCE OF ANY MATERIAL OR SERVICES WITH ANY PARTICULAR SPECIFICATION WHERE SUCH WAIVER IS CONSIDERED TO BE IN ITS BEST INTEREST, INCLUDING BUT NOT LIMITED TO CASES WHERE SUCH WAIVER IS NECESSARY DUE TO TECHNICAL ERRORS OR INCONSISTENCIES IN THE PREPARATION OF SUCH SPECIFICATIONS.

PRODUCT BID MUST MEET OR EXCEED ALL SPECIFICATIONS AS OF THE TIME AND DATE OF BID OPENING.

MODEL PROCUREMENT REGULATIONS

EXCUSE FOR NON-PERFORMANCE

THE SUCCESSFUL VENDOR(S) SHALL BE EXCUSED FROM PERFORMING HEREUNDER DURING THE TIME AND TO THE EXTENT THAT THEY ARE PREVENTED FROM OBTAINING, DELIVERING OR PERFORMING IN THE CUSTOMARY WAY BECAUSE OF FIRE, STRIKE, PARTIAL OR TOTAL INTERRUPTION OF, LOSS OR SHORTAGE OF TRANSPORTATION FACILITIES, LOCKOUT, COMMANDEERING OF RAW MATERIALS, PRODUCTS, PLANTS OR FACILITIES BY THE GOVERNMENT WHEN SATISFACTORY EVIDENCE THEREOF IS PRESENTED TO THE OTHER PARTY, PROVIDING IT IS SATISFACTORILY ESTABLISHED THAT THE NON-PERFORMANCE IS NOT DUE TO THE FAULT OR NEGLIGENCE OF THE PARTY NOT PERFORMING.

PENALTIES

IN CASE OF DEFAULT BY THE VENDOR, THE BOARD OF EDUCATION MAY PROCURE THE ARTICLES OR SERVICES FROM OTHER SOURCES AND MAY DEDUCT FROM ANY UNPAID BALANCE DUE THE VENDOR FOR THE AMOUNT OF THE EXCESS COST SO PAID, AND THE PRICE PAID SHALL BE CONSIDERED THE PREVAILING MARKET PRICE AT THE TIME SUCH PURCHASE IS MADE.

<u>TAXES</u>

THE FEDERAL EXCISE TAX AND THE KENTUCKY SALES AND USE TAX ARE NOT TO BE IMPOSED AS THE BOARD OF EDUCATION WILL FURNISH THE SUCCESSFUL BIDDER WITH PROPER TAX EXEMPTION CERTIFICATES UPON REQUEST.

PRODUCT EVALUATION

ITEMS WILL BE DISQUALIFIED THAT DO NOT MEET SPECIFICATIONS OR THE ACCEPTED EQUAL. IF A PRODUCT IS PURCHASED AND IT IS LATER ESTABLISHED THAT SAID PRODUCT FAILS TO COMPLY WITH THESE SPECIFICATIONS AND CONDITIONS, THE ITEM WILL BE REJECTED AND RETURNED TO THE SUPPLIER AT THE SUPPLIER'S EXPENSE. NON-DISCRIMINATION

2. THE SELLER SHALL IN ALL SOLICITATIONS AND/OR ADVERTISEMENTS FOR EMPLOYEES PLACED BY OR ON BEHALF OF THE SELLER, STATE THAT ALL QUALIFIED APPLICANTS SHALL RECEIVE CONSIDERATION FOR EMPLOYMENT WITHOUT REGARD TO AGE, COLOR, CREED, HANDICAP CONDITION, MARITAL OR PARENTAL STATUS, NATIONAL ORIGIN, RACE, SEX, VETERAN STATUS, OR POLITICAL OPINION OR AFFILIATION.

3. THE SELLER SHALL CAUSE ANY SUBCONTRACTOR ENGAGED TO PERFORM ANY SERVICES REQUIRED BY THIS CONTRACT TO INCLUDE THIS EQUAL OPPORTUNITY CLAUSE IN ALL SOLICITATIONS, ADVERTISEMENTS AND EMPLOYMENT PRACTICES IT SHALL PERFORM.

<u>DELIVERY</u>

THE CONTRACTOR AGREES TO FURNISH AND DELIVER THE ITEMS WITHIN THE TERMS OF THE CONTRACT AS THE BOARD OF EDUCATION MAY PRESCRIBE.

ALL COSTS FOR DELIVERY, INCLUDING DRAYAGE AND FREIGHT, AND FOR THE PACKAGING OF SAID ARTICLES ARE TO BE BORNE BY THE BIDDER, AND MUST BE INCLUDED IN YOUR BID PRICES.

ALL ITEMS ARE TO BE SHIPPED INSIDE DELIVERY FOR SCHOOL LOCATIONS. ITEMS DESIGNATED FOR WAREHOUSE ONLY MAY BE TAILGATE DELIVERY.

SPECIAL CONDITIONS AND SPECIFICATIONS

The successful bidder shall follow the guidelines outlined in KRS 158.854 regarding administrative regulation specifying minimum nutritional standards for food sold outside school lunch program and 702 KAR 6:090 regarding the minimum nutritional standards for foods and beverages available on public school campuses during the school day.

The successful bidder shall furnish vending machines to all schools and locations within the Clay County Public School System including the Bus Garage and Central Office locations. Electrical outlets shall be provided for each machine by the Clay County Board of Education. The successful bidder shall be required to deliver and install the vending machines. Extension cords shall not be used.

Volume of sales and/or request made by Clay County Board of Education shall determine the number and type of machines to be placed in each location with the following stipulations: (1) dollar bill validators shall be installed at each vendor location to allow free flowing of traffic at vending machines, (2) the successful bidder shall provide refunds for money lost in its vending machines, (3) vending machines shall be updated and relocated whenever needed in order to maintain an attractive image for schools, (4) repairs shall be the responsibility of the successful bidder and shall be made in a 24 hour period after notice of repair needed, (5) each machine will have a vend rate no greater than \$1.00 per item, (6) security locks to hinder theft or vandalism shall be the responsibility of the vendor, and (7) the successful bidder must provide the most energy efficient vending machines available.

All beverages shall be delivered weekly to all schools and locations within the Clay County Public School System. Deliveries shall be made on weekdays only between the hours of 7:00 am and 4:00 pm EST. All products are to be delivered at no charge, including the initial fill up of the vending machine(s) when delivered. It is the successful bidder's responsibility to empty, balance and refill money changers.
