



Board Briefs



June 28, 2011 Meeting

Minutes from the May 2 (two separate meetings), 10, 25, and 31, 2011 Board meetings were approved.

The following **Finance/Audit** recommendations were approved:

- ❖ Financial reports for all funds, Budget Modification report, Fund to Fund Transfers and the Check Payment Register report for May 2011.
- ❖ Resolution to approve the 2011-2012 pay-to-participate fee at \$150 per activity; if the August 2, 2011 levy fails the 2011-2012 pay-to-participate fee will be \$200 for middle school per activity and \$225 for high school per activity with no family maximum.
- ❖ Resolution deeming NSF checks dating from November 1998, and have been processed for collection through E-Collect, are uncollectable and that a total of \$7,118.28 be written off the Riverside books.
- ❖ Resolution that outstanding Board issued checks, totaling \$7,600.85 dating back to 2007, shall be receipted into the General Fund and said checks cancelled.
- ❖ Resolution approving final appropriations for the fiscal year ending June 30, 2011 as recommended by the Treasurer.
- ❖ Resolution approving temporary appropriations for the fiscal year ending June 30, 2012 as recommended by the Treasurer.
- ❖ Resolution that Policy 6140 DEPOSITORY AGREEMENTS be changed to read in part five years in order to conform to law O.R.C. 135.01 to 135.21.
- ❖ Resolution that Ohio Revised Code Section 135.01 to 135.21 constituting "The Uniform Depository Act" governs the deposit of all public money of the Board of Education; and present depository designations of the Board expire as of August 21, 2011.
