Nancy Fleming, School Counselor, discussed the ACE's report that the students and staff took several weeks ago. The ACE's report asks questions regarding traumatic events in their lives, and how these hinder the ability to learn in the classroom. Ms. Fleming provided the board members with the results of the report, along with a packet explaining what the results show from our students.

Administration – provided a list of NWEA Map goals and results for the school year. Kagan coaching is on March 15<sup>th</sup> and Kagan training is March 16<sup>th</sup>. Parent-Teacher Conferences are Thursday, March 15<sup>th</sup>. The Elementary teachers hosted a Title night for families on March 5<sup>th</sup>.
