See How Your School District Is Recovering From the Pandemic

By Francesca Paris Feb. 1, 2024

Elementary and middle-school students are recovering from pandemic learning losses, according to a new study by researchers at Stanford and Harvard.

But there are huge differences across the country. Some school districts are testing better than in 2019. Many more are still worse off. (Read our full analysis here.)

This tool includes math test scores for public school districts from 41 states. Several states — New York among them — are excluded because of low test participation rates or insufficient public data.

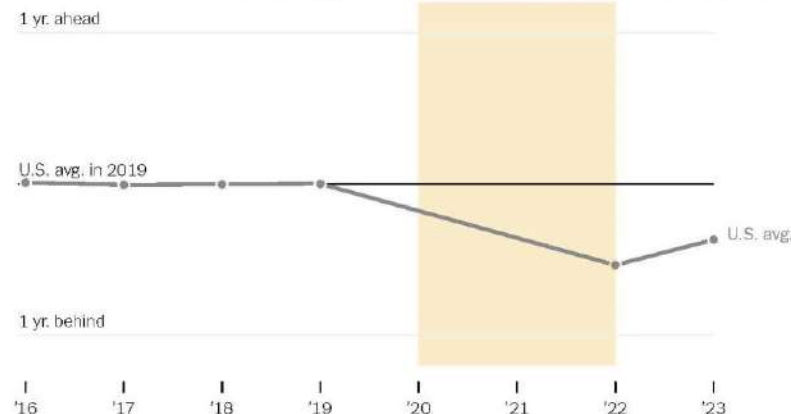
Other states, including Texas and Florida, have data only through 2022 because of changes to their state tests. Each circle represents a year of testing; there was no testing in the spring of 2020 and incomplete testing in 2021.

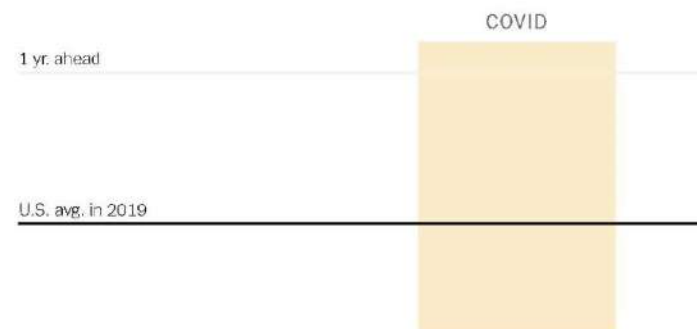

Attendance Policy

- **Minimum School Day (Section I of Policy JBL)**
 - House Bill 1530 amends Miss. Code Ann. § 37-13-91, known as the Mississippi Compulsory School Attendance Law, to provide that a compulsory-school-age child who is absent more than 37% of the instructional day must be considered absent the entire day. Therefore, for the purposes of determining and reporting attendance, a student must be present for at least sixty-three percent (63%) of the instructional day to be considered present the entire school day.



Early Release Policy

- **Early Release (Policy IGBA)**
 - For early release, students must meet College and Career Readiness benchmarks of 17 in English and 19 in Math on the ACT sub-score OR earn a Silver level on the ACT WorkKeys suite of assessments.
 - There are additional requirements for students who do not meet the benchmarks to qualify for early release, excluding those enrolled in credit-bearing work-based learning.



Consider Implementing a Late Arrival in Addition to Early Release

Additional time to get to school	Students still late/tardy
Helps with tardiness	Qualified students may not have transportation
Helps with class size	
Assist with raising ADA (Average Daily Attendance)	
Added incentive for responsible students.	



As it Relates to Policy

- A student must be present for at least sixty-three percent (63%) of the instructional day to be considered present the entire school day.
- Early release policy does not state which part the 63% of the instructional day has to be.

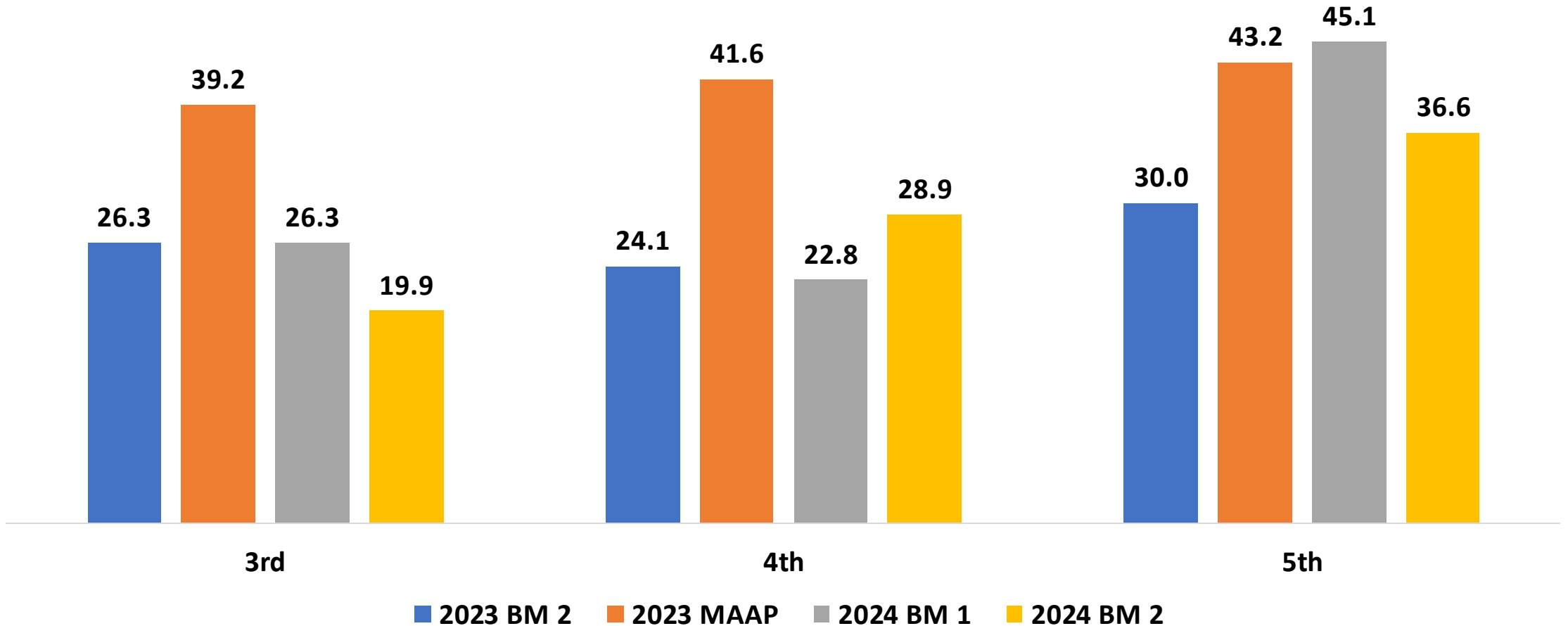




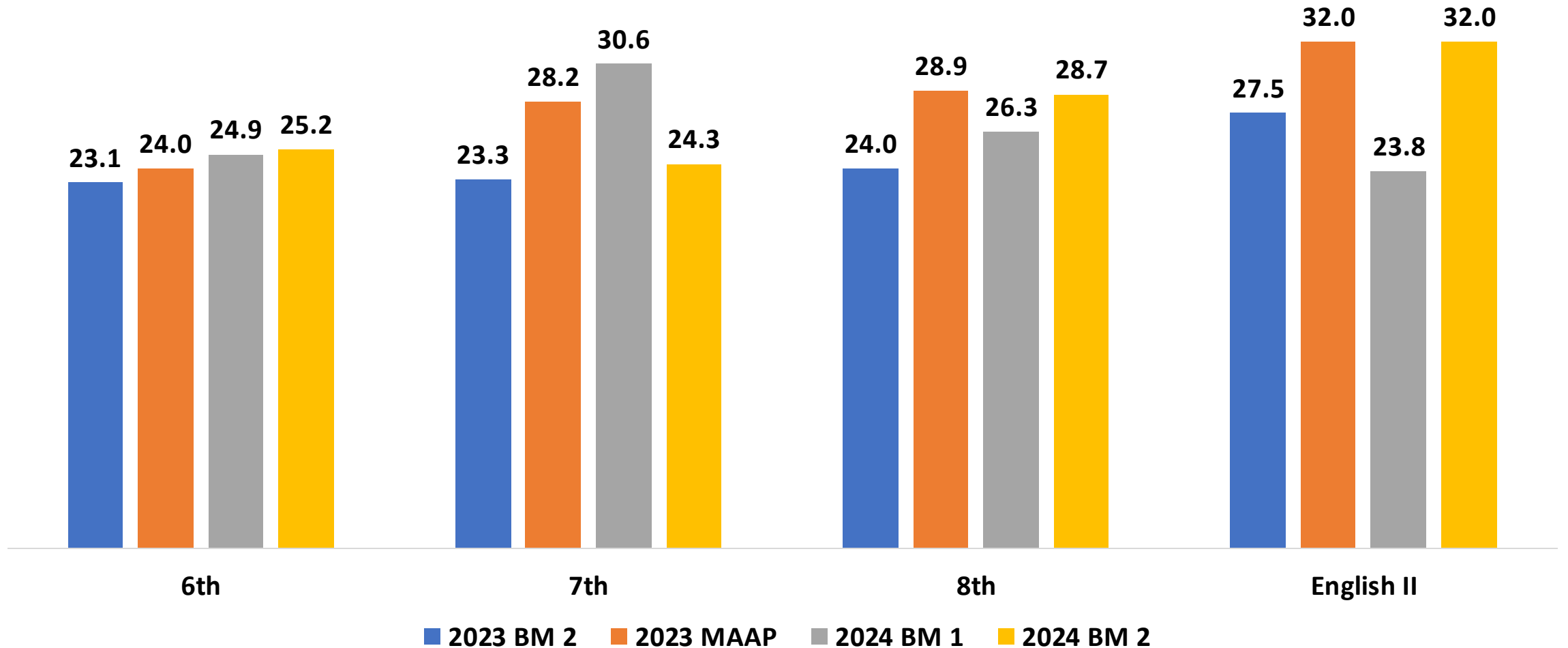
Overall (ELA) Proficiency 2022 – 2024 Benchmark Assessment Results

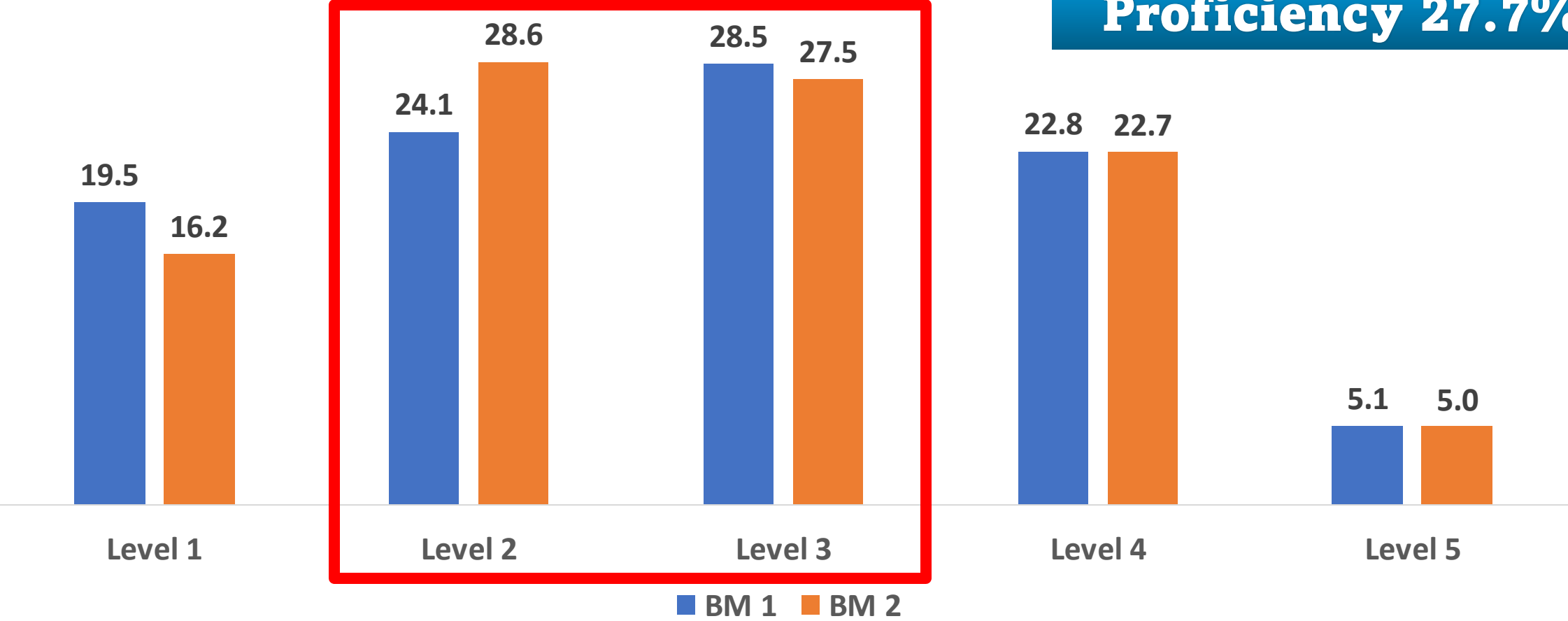


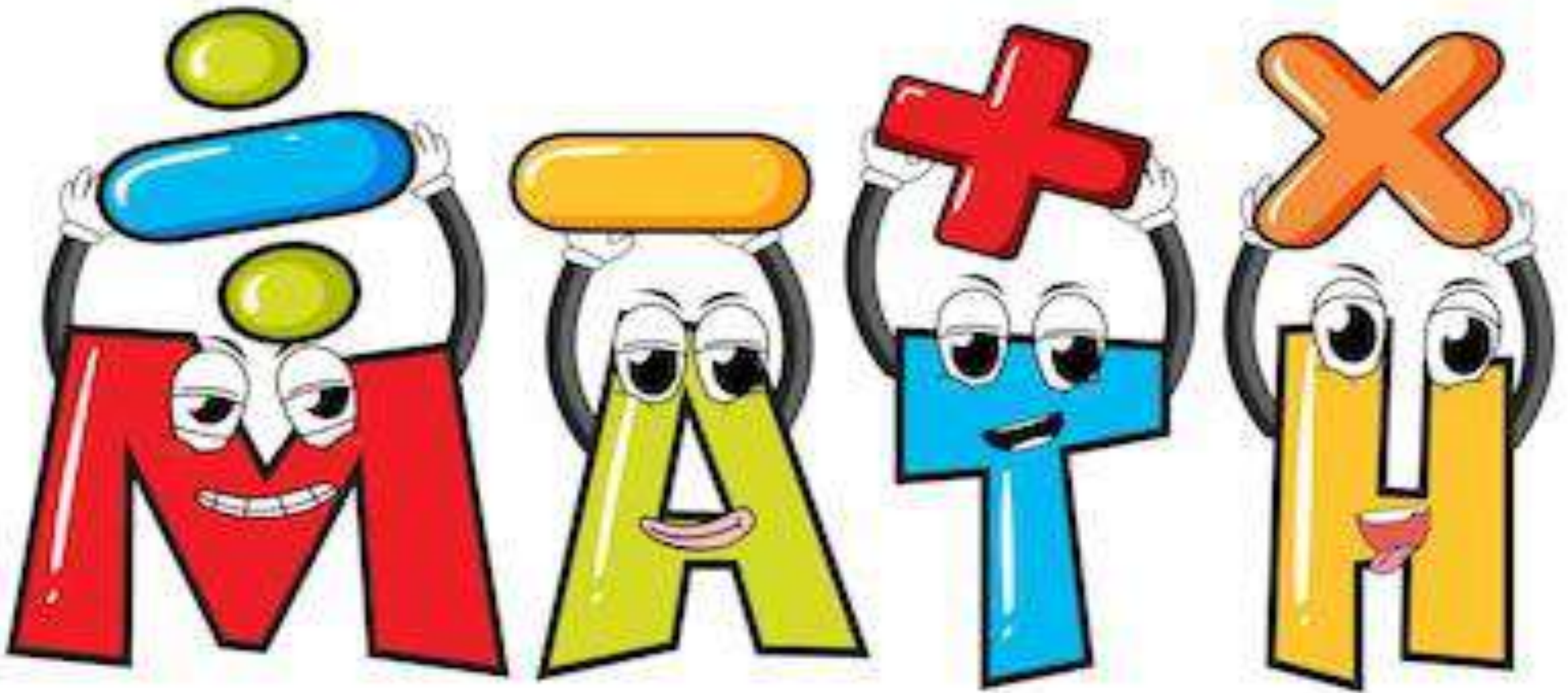

ELA Performance Levels 1 - 5

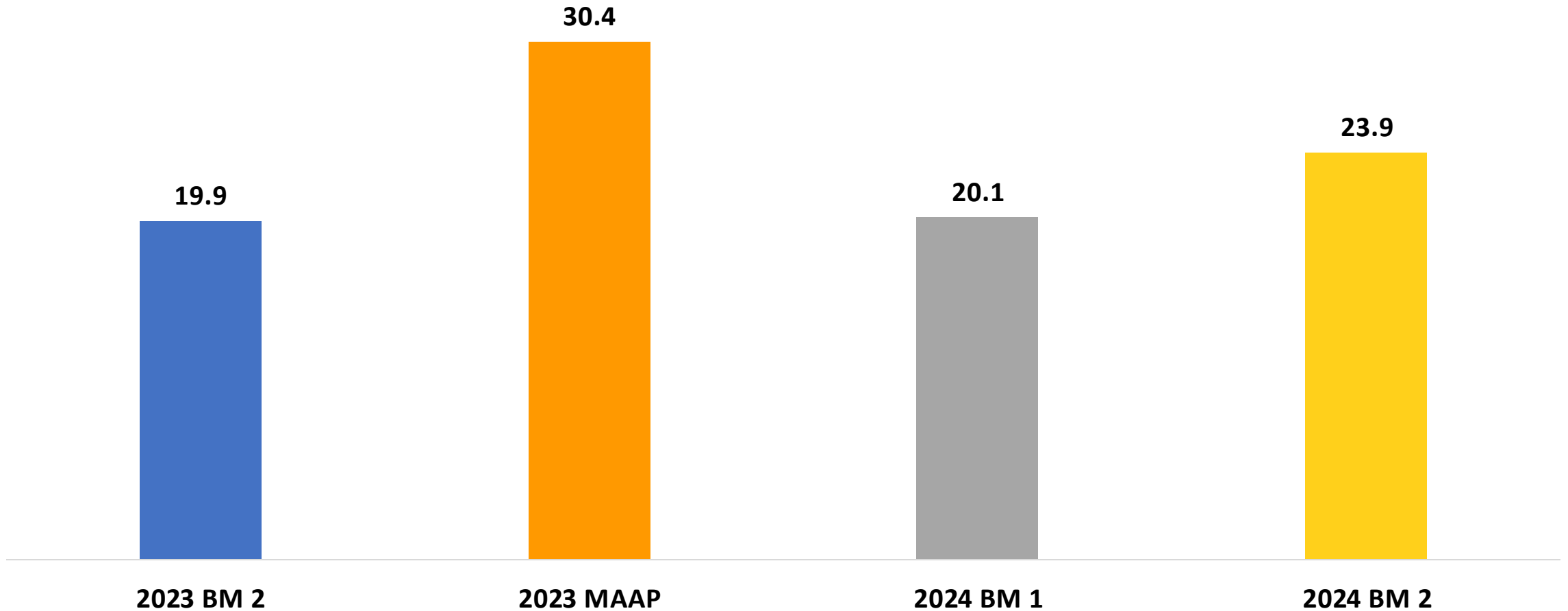

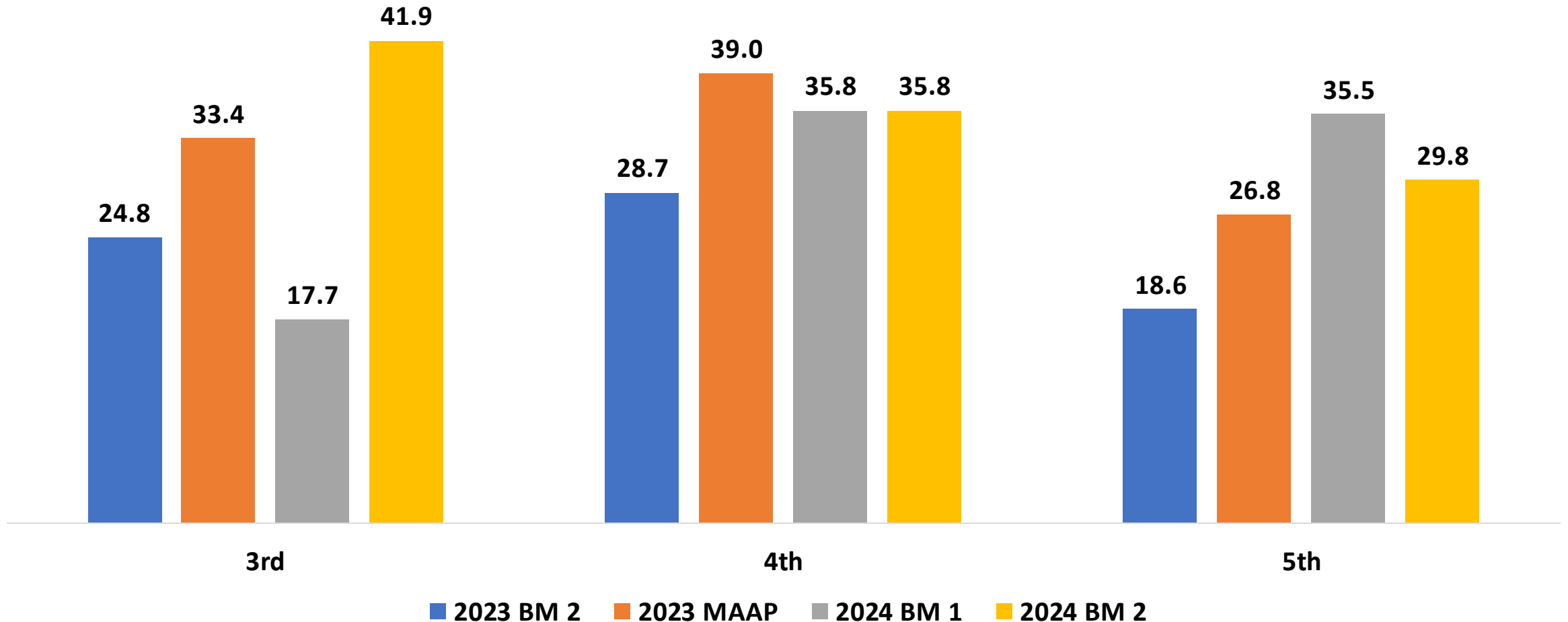

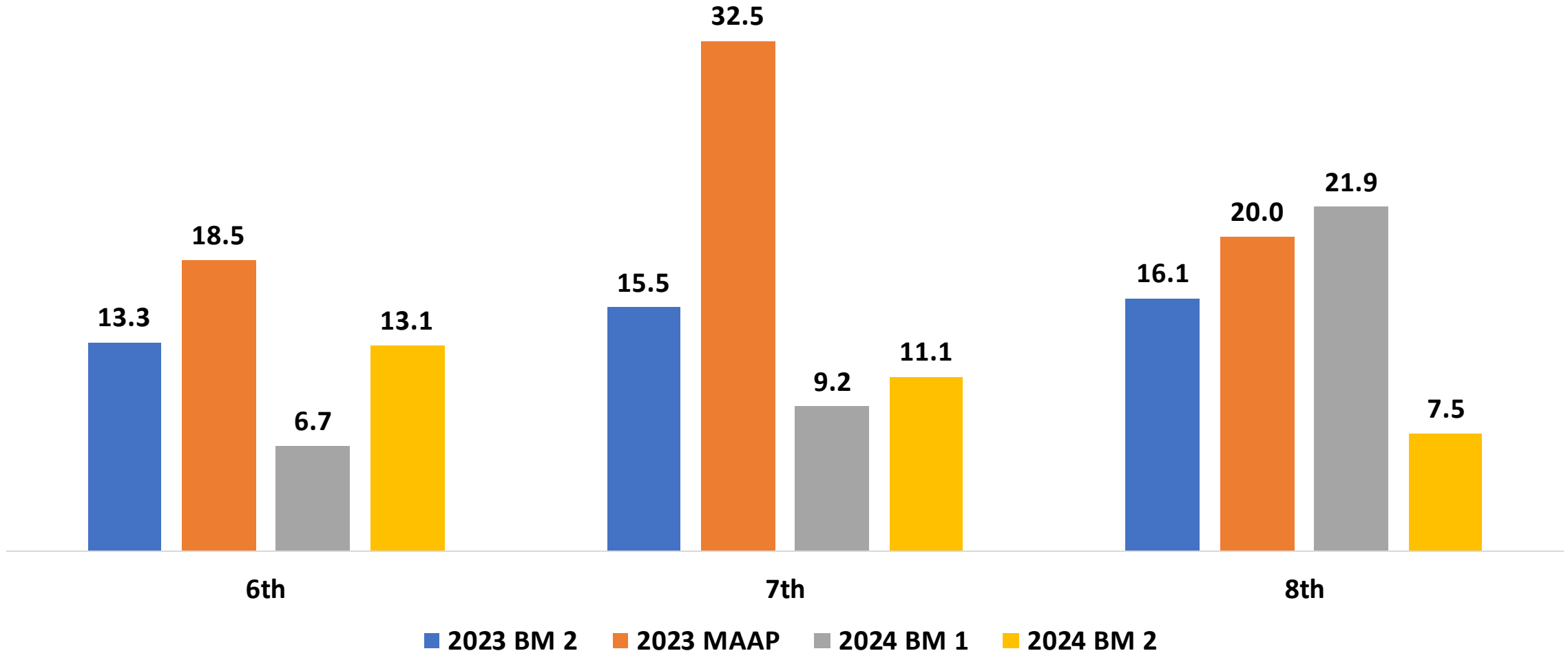
Overall (Math) Proficiency 2022 – 2024



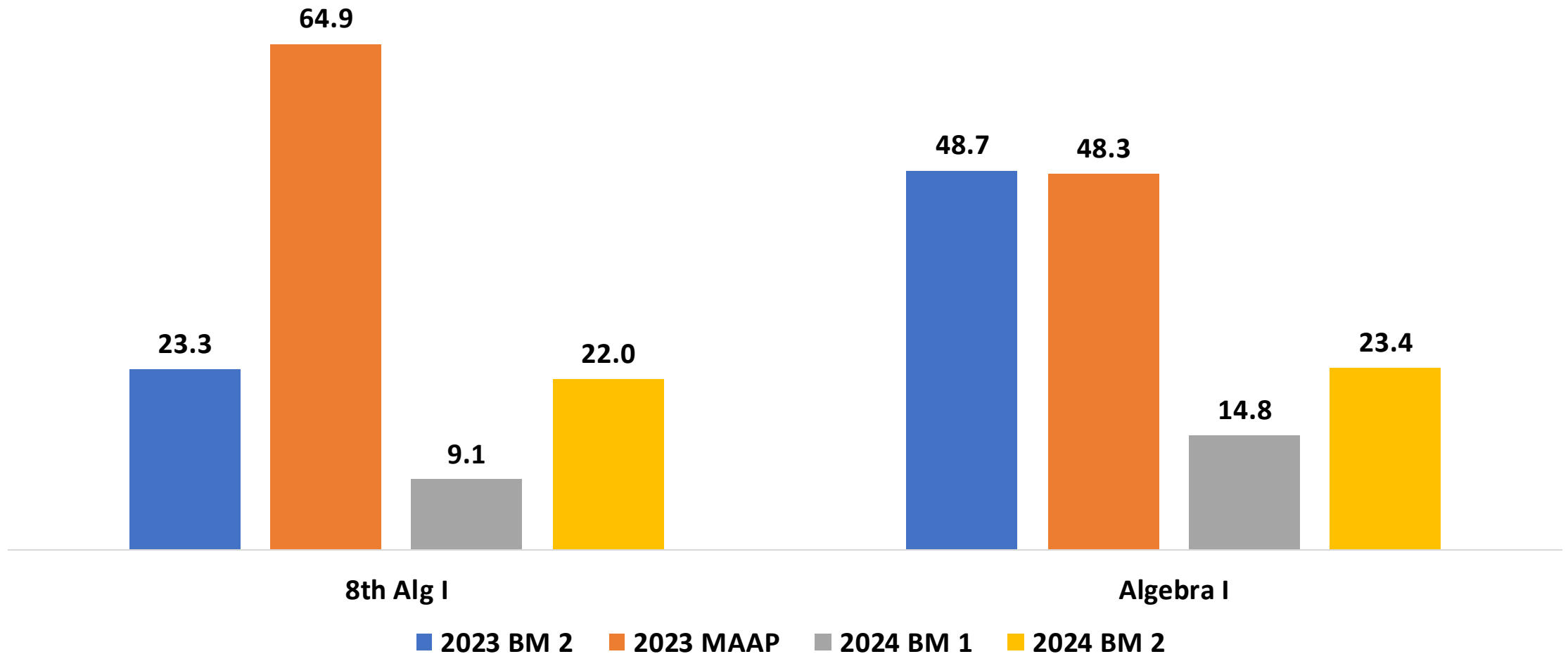
Elementary Benchmark (Math) 2022 – 2024



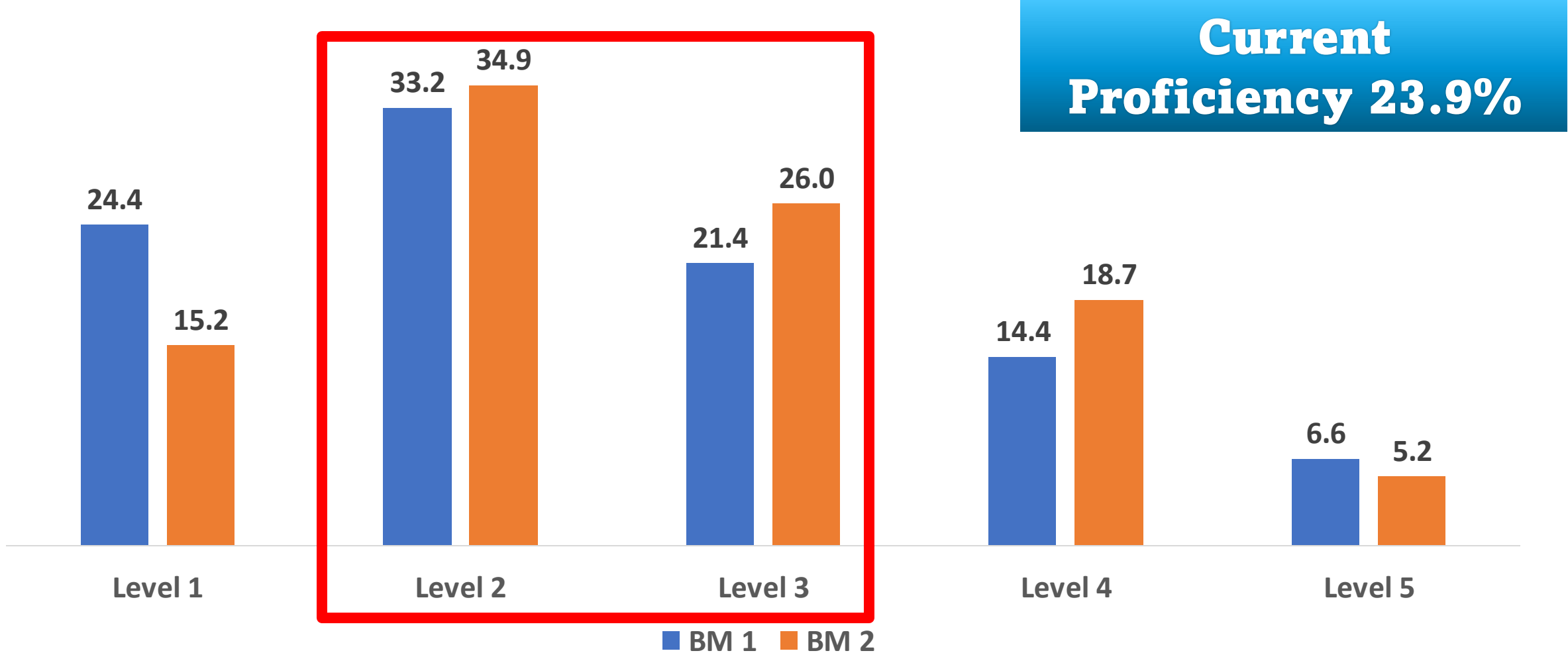
Secondary Benchmark (MATH) 2022 – 2024



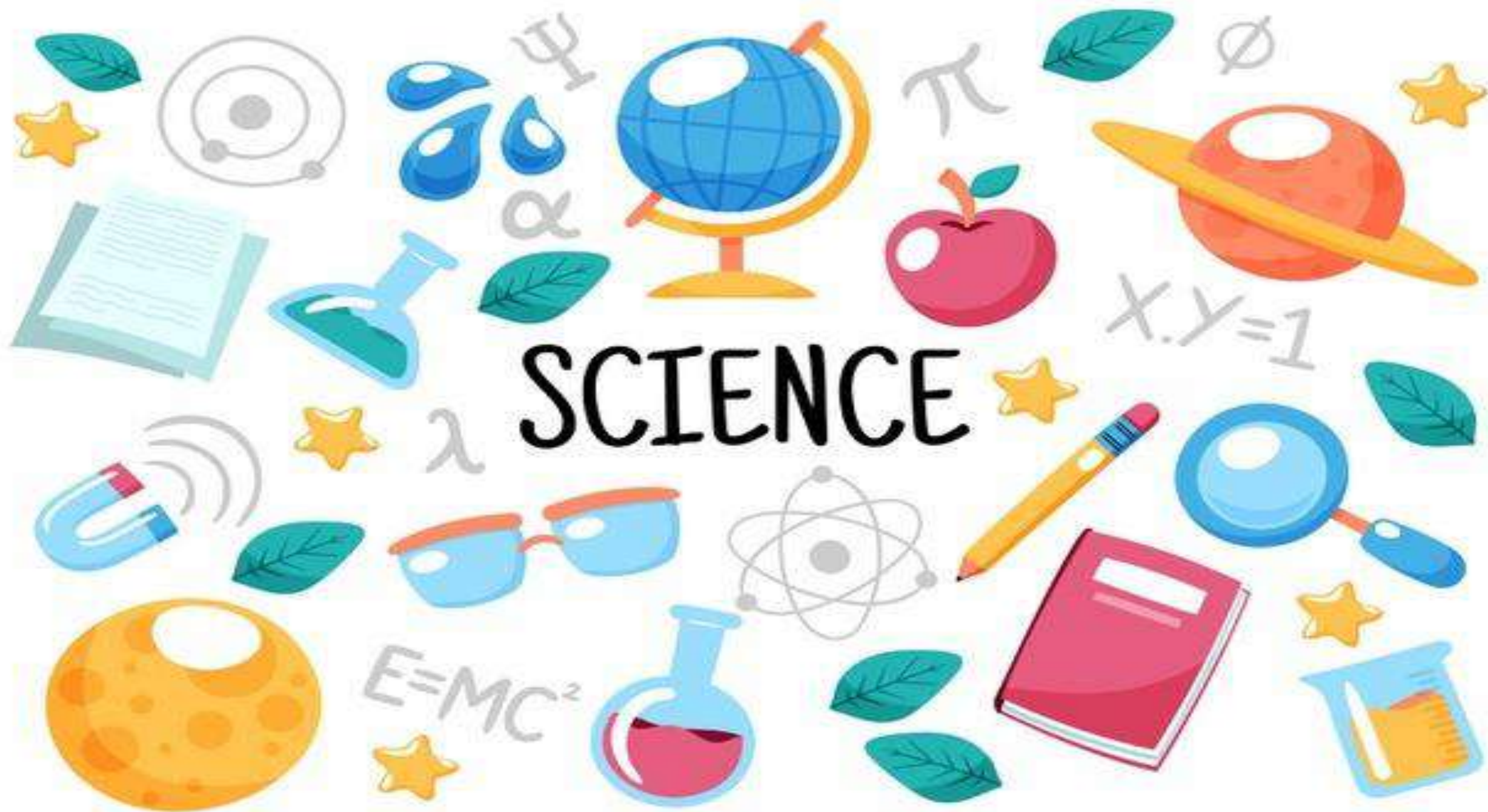

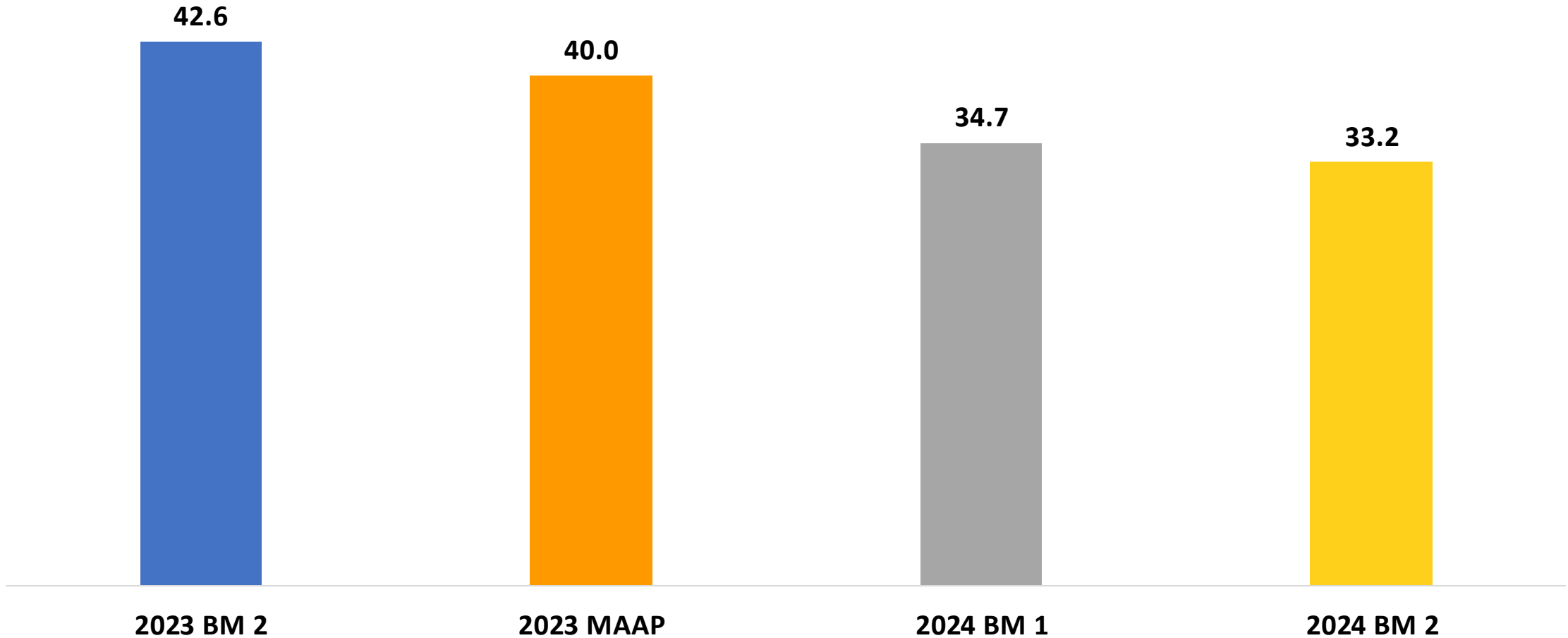
Mathematics Performance Levels 1- 5



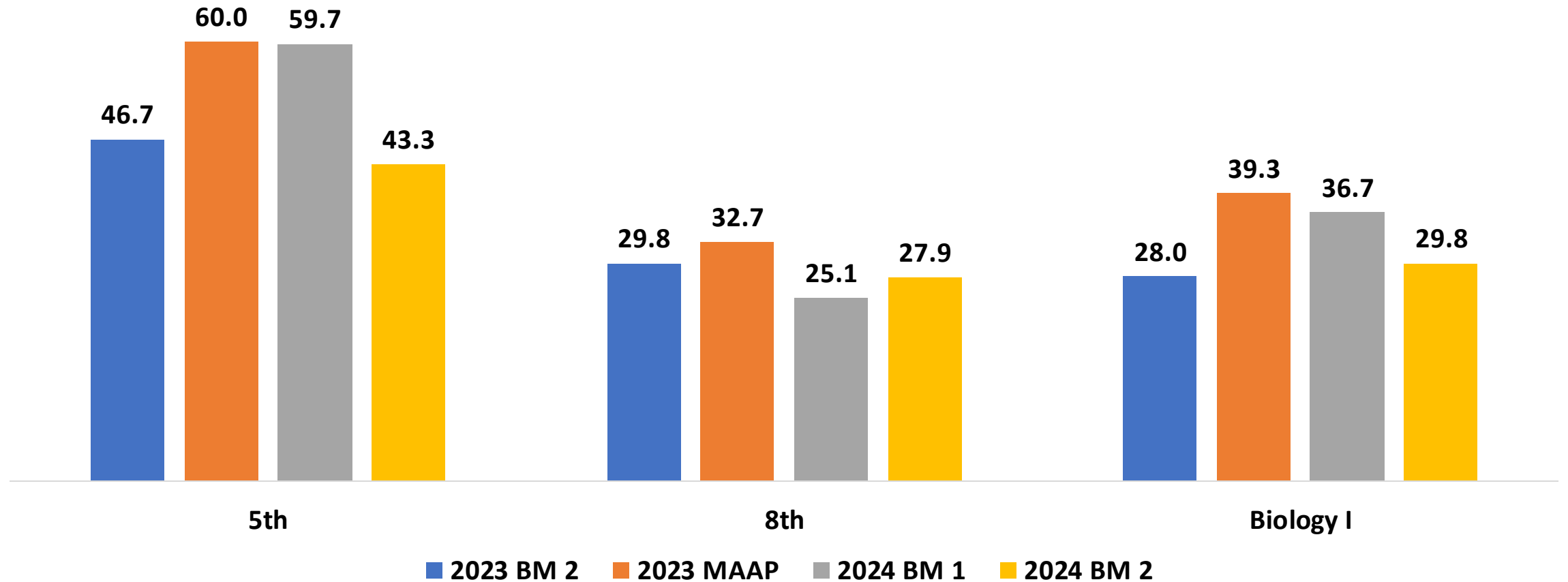

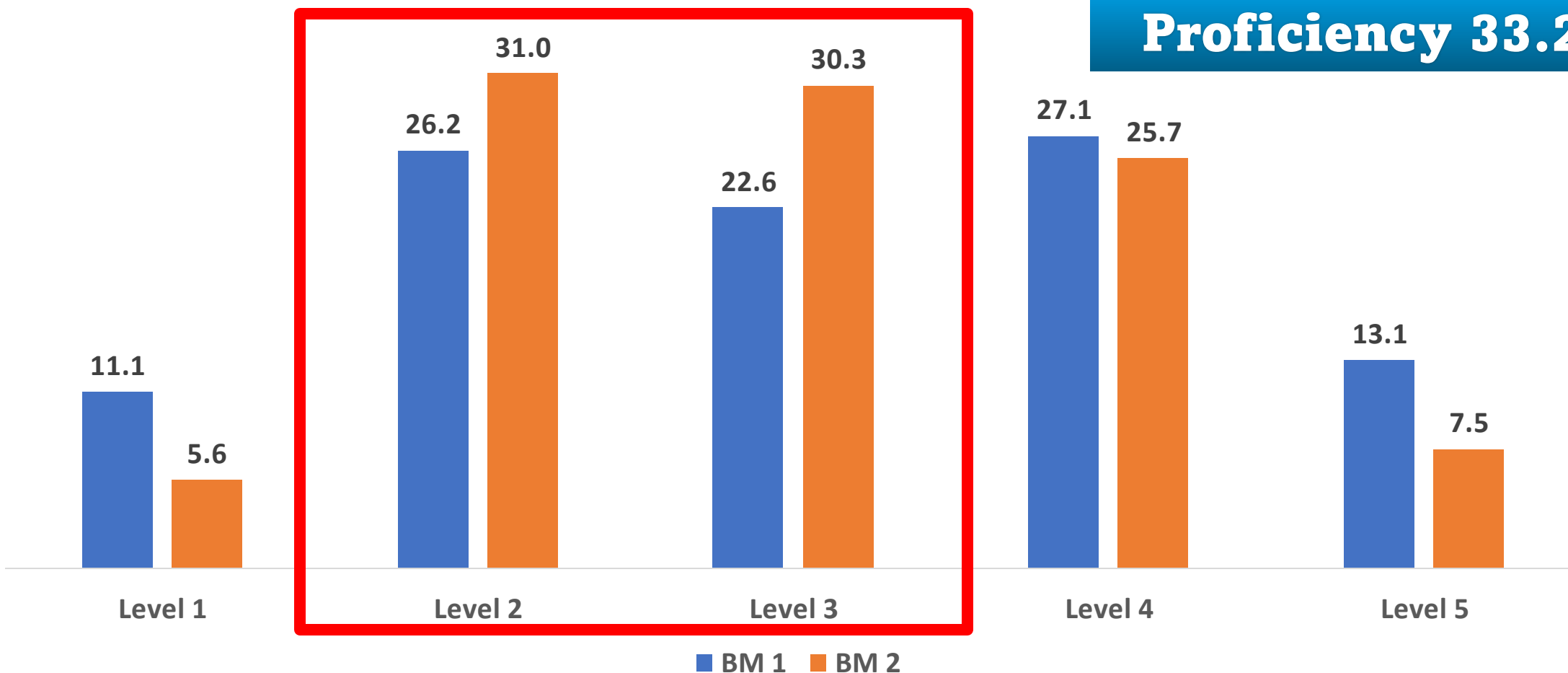

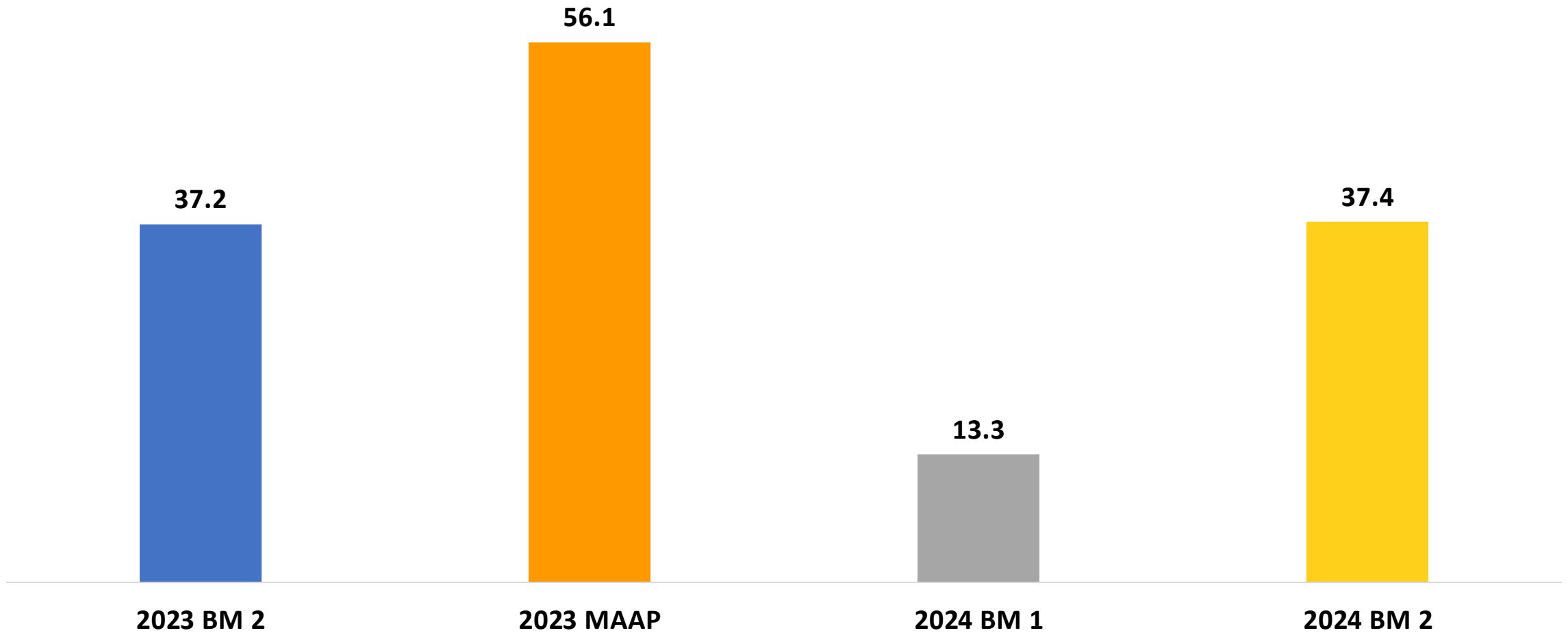

NEXT STEPS

- Ensure adequate time for diagnosing, practicing, and re-evaluating the standards to achieve mastery.
- Offer targeted professional development sessions for teachers facing challenges, concentrating on enhancing instructional strategies.
- Closely monitor the progress of the district's lowest-performing students to ensure the advancement of all scholars.
- Establish dedicated time during data meetings to discuss strategies tailored to address the unique needs of different student subgroups.
- Encourage the teacher to allow students to take the time to discuss errors ("Chat the Error") as a means to enhance their understanding of standards or assessment items.

NEXT STEPS

- Conduct professional development sessions aimed at aligning assessment, teaching, and curriculum for teachers to enhance their instructional practices
 - Is the assessment item aligned with the learning standards and objectives?
 - What part of the standard does this assessment item address?
 - What instructional strategies will ensure mastery of the item/standard?
 - How well do the instructional strategies align with the assessment item used in the classroom?
 - What misconceptions should we anticipate based on the distractors?
 - Is the overall assessment, instructional strategies, and difficulty level consistent with MDE's text complexity and blueprint guidelines?

NEXT STEPS

- Strengthen the focus on grades K – 2 to improve performance in grade 3 and beyond.
 - Emphasize Kindergarten students should be reading proficiently by February.
 - Students in grades 1 – 5 should achieve fluency in addition and subtraction before entering 3rd grade
 - Implement a district-wide emphasis on fluency, encompassing addition, subtraction, multiplication, and division
- Continue providing ELS platform training to strength the use of the platform and understanding the reports.

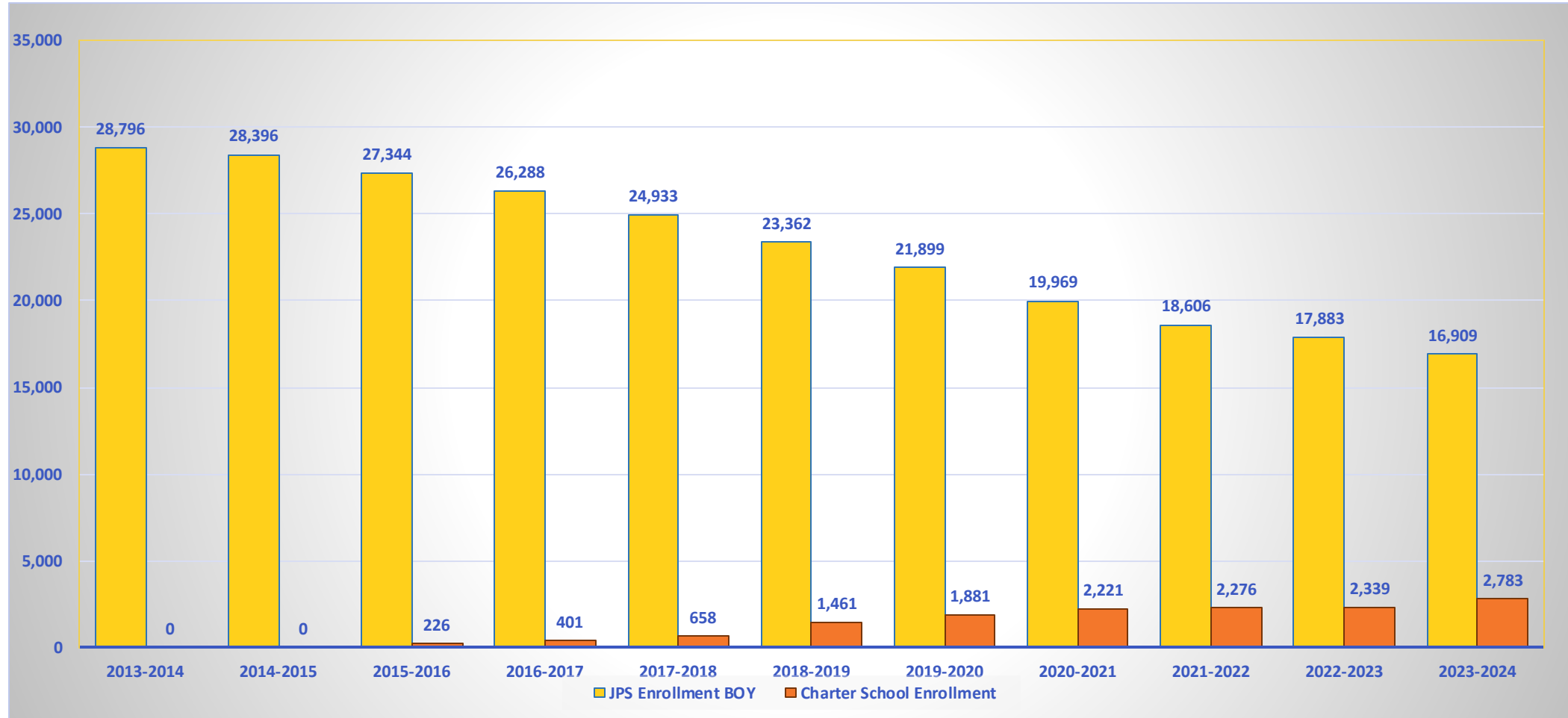

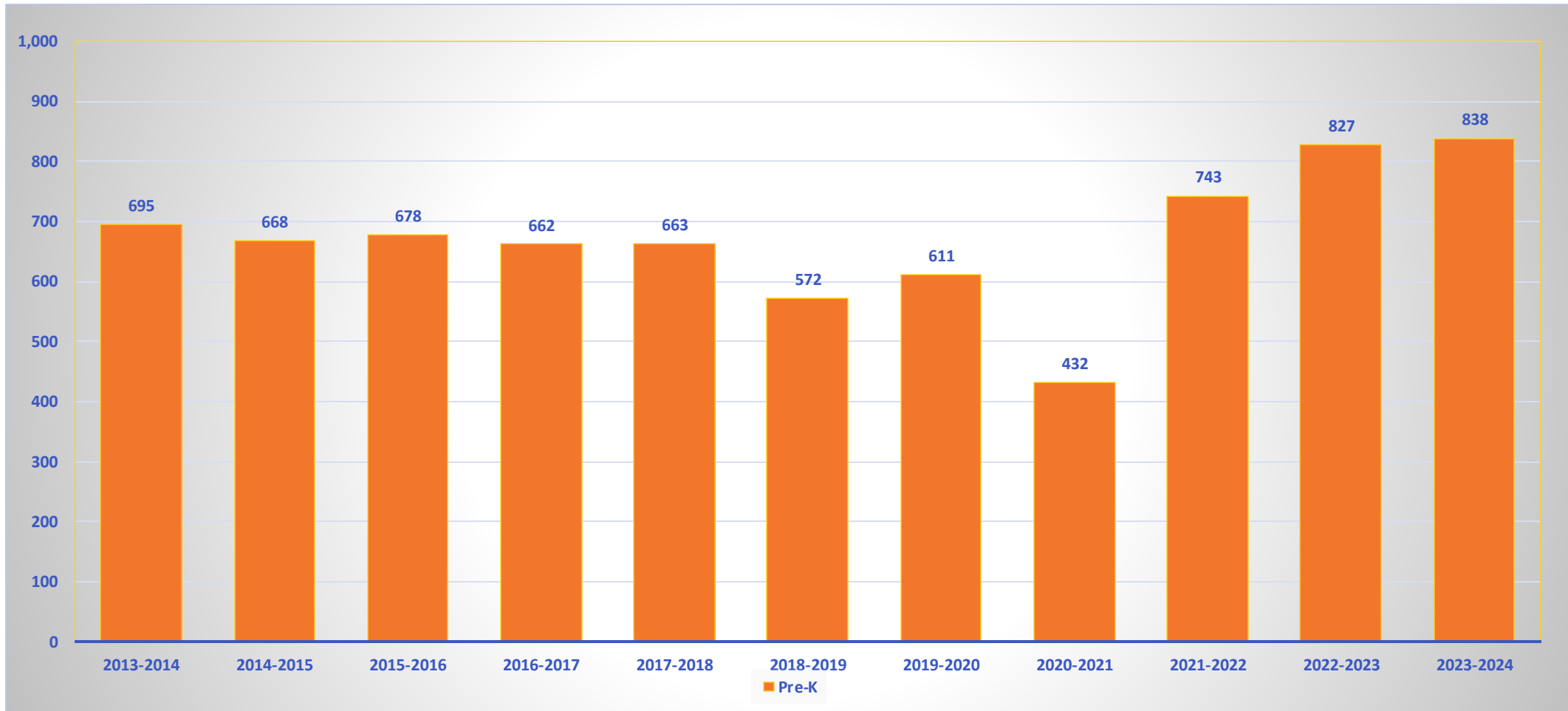

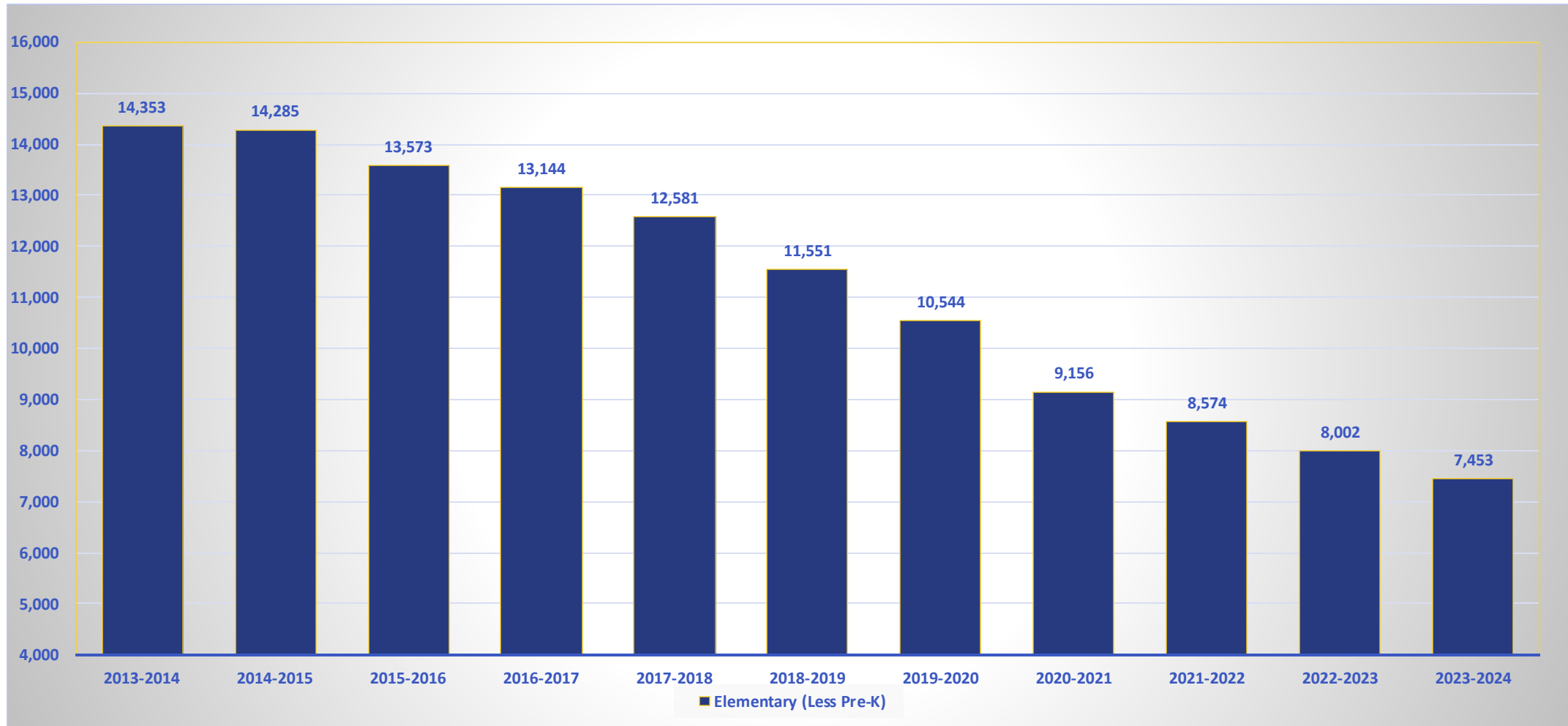
Month 1 Enrollment Comparison

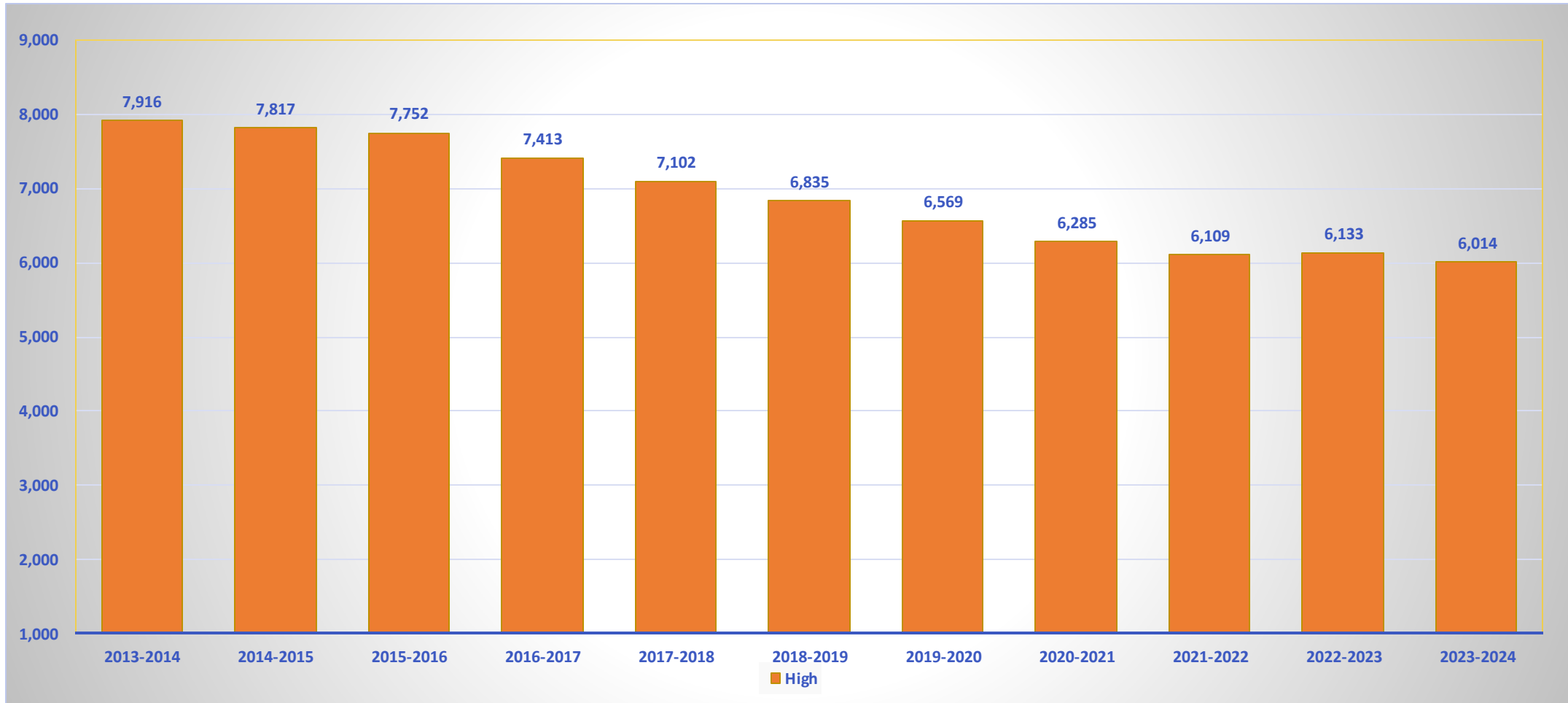

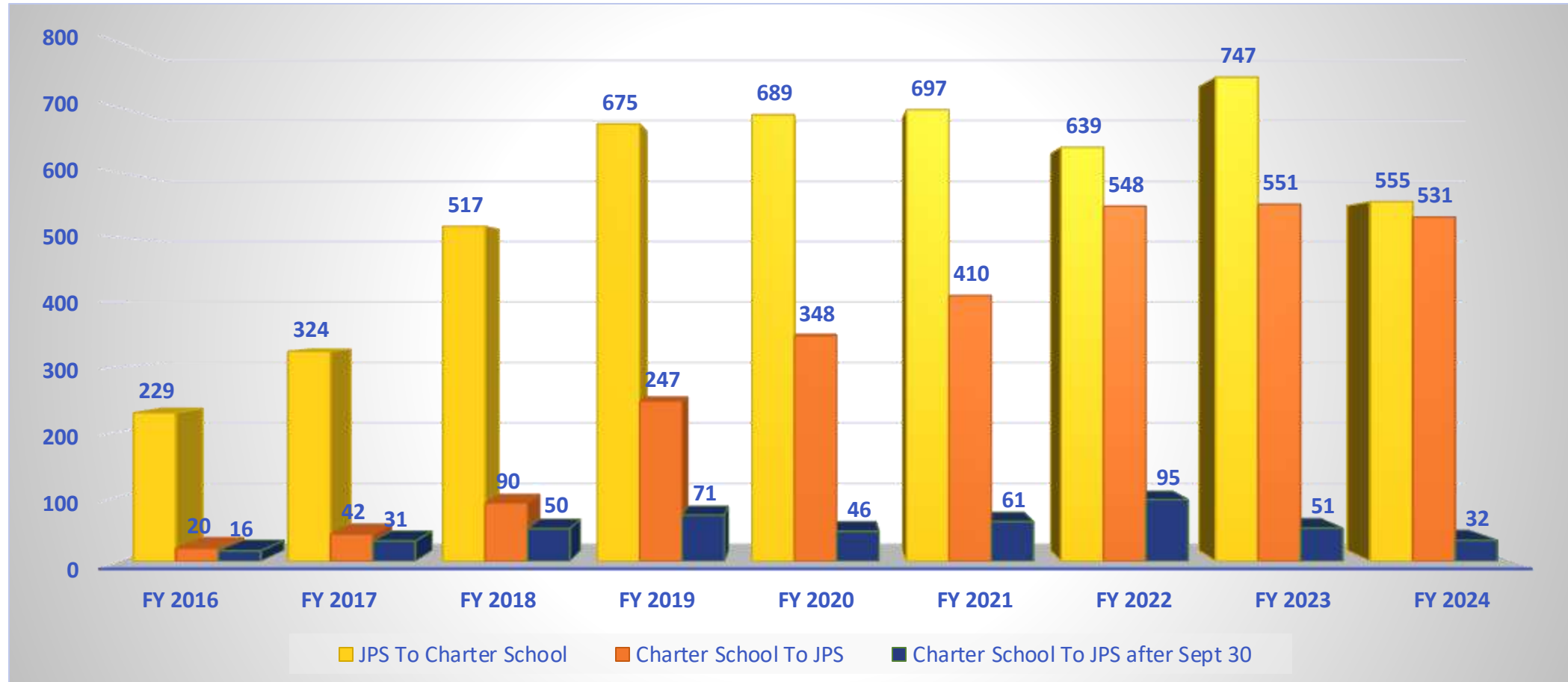

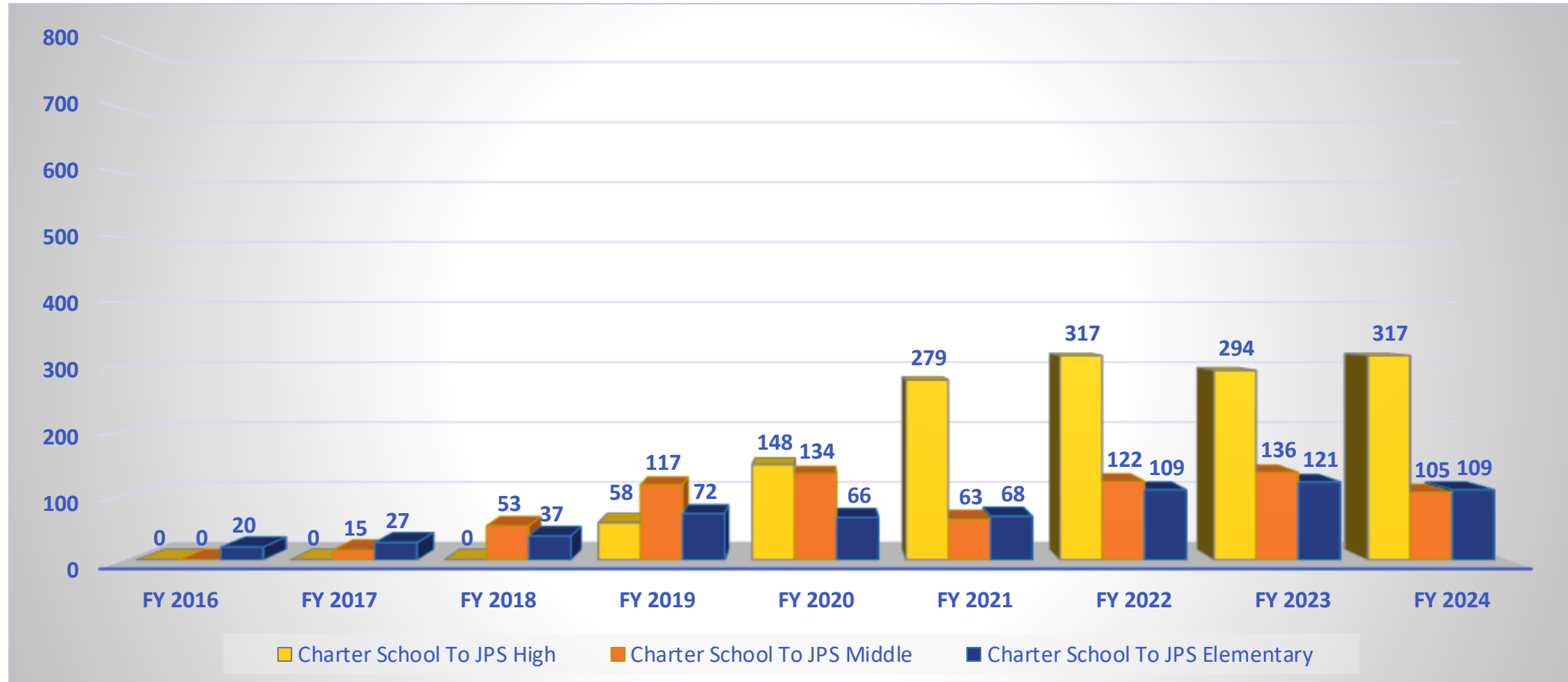

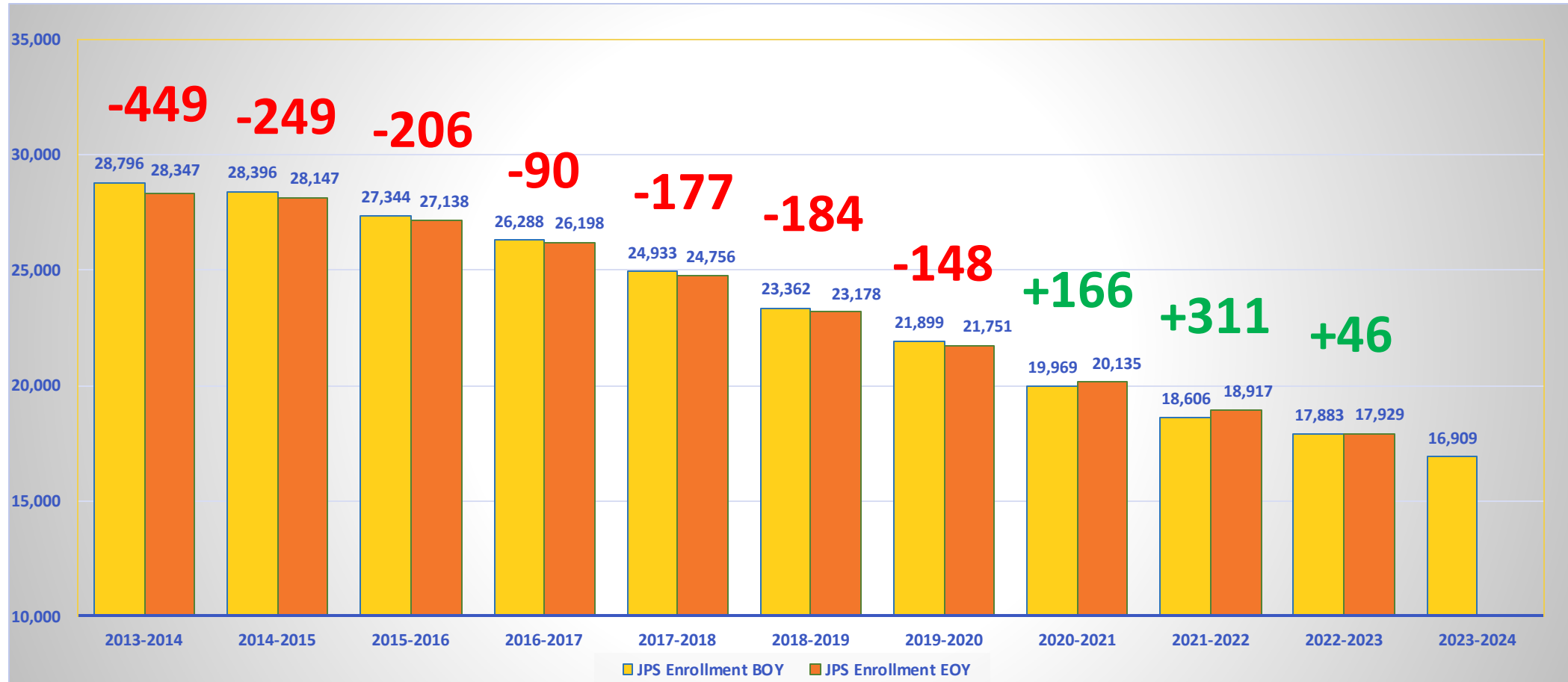
Charter Transfer Trends

Enrollment Takeaways

- ❖ Over the past 10 years, JPS has seen a significant decline in enrollment.
41% (11,887 students)
- ❖ There has been an increase in Pre-K enrollment due to the District being awarded the Early Learning Collaborative Grant in 2021-2022.
- ❖ Significant Decrease: Elementary Division - 48% decline (6,900 students)
- ❖ Charter to JPS Enrollment – High School Division (No Charter Schools for 9-12)
- ❖ BOY/EOY Comparison (Average enrollment change -98 students)
