RE: **Recommendation for Approval of Equipment Pre-Purchase**

On November 9, 2023 the district advertised a Request for Proposals for the Air Handling Units and Vertical Unit Ventilators for projects at Rochester Adams High School, North Hill, Meadow Brook and ACE, in the local publication, the Rochester Post, and posted RFP documents on the Purchasing pages of the district's website, Sigma, and BidNet Direct. The district received two (2) responses for one (1) category of construction trade on the due date. A public reading of bids received was conducted on November 28, 2023 at 2:00pm.

This request is to fund the equipment cost to purchase the replacement air handling and HVAC equipment for Adams, North Hill, Meadow Brook and ACE. The equipment request for Adams includes 2 air handling units. These units serve the large open space outside of the Counseling Offices, the Cafeteria and surrounding corridors. The current air handling units are 30 years old and replacement parts are no longer available. The equipment for North Hill includes 27 vertical unit ventilators, Meadow Brook includes 19 vertical unit ventilators and ACE includes 7 vertical unit ventilators. The vertical unit ventilators provide heating and cooling for the classrooms and are 20 plus years old. These units are beginning to fail and repair parts are no longer available.

Due to the long lead-times of this equipment, bid documents for purchase of the equipment were issued as a separate bid package, ahead of the installation drawings, so that the equipment can be ordered and arrive in time to be installed in the Summer of 2024. A future funding request will follow in February requesting the funding for the installation of this equipment.

Bids were reviewed and evaluated by a team from Frank Rewold and Son Inc., and by Pete Muscio, Director of Capital Projects for Rochester Community Schools. All of the accepted bids were found to be initially compliant with the required specifications per the detail in the bid summary. The bids were analyzed on bid content, completeness, inclusion of required submittals, and compliance with required specifications. Interviews and evaluations were conducted according to the attached documentation and

recommendation submitted by Mike Gagnon of Frank Rewold & Son which was reviewed by Peter Muscio and Jennifer Fickel, Purchasing Supervisor.

The source of funding is the Sinking Fund.

Based on this information, we recommend **THAT the Board of Education award the following contracts to:**
