### **0167 PUBLIC PARTICIPATION IN BOARD MEETINGS**

The Board of Education recognizes the value of public comment on educational issues and the importance of allowing members of the public to express themselves on school matters of community interest. In order to permit the fair and orderly expression of such comment, the Board shall provide a period for public comment at every regularly scheduled meeting of the Board. Public participation shall be governed by the following rules:

1. All statements shall be directed to the presiding officer. No participant may address or question Board members individually unless directed by the presiding officer.
2. A participant must be recognized by the presiding officer and must preface comments by an announcement of his/her name, place of residence, and group affiliation, if appropriate; Web participants will type the information in as a preface to their comments.
3. If the Board of Education is webcasting the public meeting, the "chat" feature will be on during the public comment sessions only.
4. No participant may speak more than once on the same topic unless all others who wish to speak on that topic have been heard and time permits.
5. In order to provide sufficient opportunity for the public to be heard, a time limit of three minutes for each participant may be observed. Webcast participants making comments via chat may only enter one 256 character comment, excluding the announcement of his/her name and place of residence, unless the presiding officer asks for clarification or further information. The President may, at his/her discretion, limit discussion on any topic.

The portion of the meeting during which the public is invited shall be limited to sixty minutes and will be concluded by 11:00 p.m.

**WHEREAS**, Readington Township Board of Education ("RBOE") desires to undertake the development and implementation of a Request for Proposals ("RFP") for the for the financing, installation, operation and maintenance of a photovoltaic energy system by a private solar developer (the "Project") intended to serve the RBOE's facilities; and

**WHEREAS**, among other benefits, the Project is anticipated to reduce energy costs for the RBOE; and

**WHEREAS**, pursuant to the Department of Community Affairs Division of Local Government Services' Local Finance Notices 2008-20, dated December 3, 2008, and 2009-10, dated June 12, 2009, the Project may be procured through competitive contracting provisions of the Public Schools Contracts Law (N.J.S.A. 18A:18A-4.1(k)); and

**WHEREAS**, pursuant to law, specifically, N.J.S.A. 18A:18A-4.3a, RBOE must adopt a resolution authorizing the use of competitive contracting in the procurement of the Project, and the issuance of the RFP;

**NOW, THEREFORE, BE IT RESOLVED by the Readington Township Board of Education, as follows:**

1. The aforesaid recitals are incorporated herein as if set forth at length.
2. The Business Administrator, or at her direction, RBOE's energy consultant and/or special counsel for the Project, are hereby authorized, on behalf of RBOE, to issue the RFP utilizing the competitive contracting process in compliance with the Public School Contracts Law, and from time to time may issue any addenda thereto as deemed necessary.

**BE IT FURTHER RESOLVED** that this resolution shall take effect immediately.

**Resolution of the Board of Education of the Township of  
Readington in the county of Hunterdon, NJ providing for  
the submission of a special ballot question to the school  
district voters at a Special School District Election to be  
held on Tuesday, January 26, 2016**

**WHEREAS**, The Board of Education of the Township of Readington in the County of Hunterdon (the "Board" when referring to the governing body and the "School District" when referring to the territorial boundaries governed by the Board) desires to undertake a school facilities project in order to undertake improvements to various schools in the School District (the "Project");

**WHEREAS**, to accomplish the Project, the Board seeks to authorize the submission of a ballot question and an explanatory question at a Special School District election to be held on Tuesday, January 26, 2016 (the "Election") and to authorize certain actions required to be taken in connection with the conduct of the Election and the undertaking of the Project.

**NOW THEREFORE, BE IT RESOLVED** by The Board of Education of the Township of Readington in the County of Hunterdon, New Jersey (not less than a majority of the full membership of the Board concurring) as follows:

1. The following Explanatory Statement and Proposal (the "Proposal") shall be submitted to the legal voters of the School District at a Special School District election (the "Election") to be held on Tuesday, January 26, 2016.

#### **EXPLANATORY STATEMENT**

##### **THE PROJECT**

The Board is seeking to undertake the following facilities improvements:

- Holland Brook School: Reconstruction/reconfiguration of parking areas and driveway
- Readington Middle School: Reconstruction/reconfiguration of parking areas and driveway and entrance/step improvements
- Three Bridges School: Entrance/step improvements

##### **TOTAL PROJECT COSTS**

The total cost of the project shall not exceed \$1,780,000. The Board has received an award of State funding in the amount of 40% of the total project costs which State funding reduces the taxpayers' share of the project to 60%.

##### **40% STATE FUNDING FOR THE PROJECT**

The Board has received State funding for the project in the form of debt service in the amount of 40%. This State aid reduces the taxpayers' share of the project to 60% of the total project cost. Such State funding will only be available if the referendum passes. The Board will be funding its 60% of debt service with monies currently on deposit in the Capital Reserve Fund so no new tax dollars will be raised to pay for the project.

#### **PROPOSAL**

The Board of Education of the Township of Readington in the County of Hunterdon, New Jersey is authorized to undertake a school facilities project consisting of (A) reconstruction/reconfiguration of parking areas and driveway at Holland Brook School; reconstruction/reconfiguration of parking areas and driveway and entry/step improvements at Readington Middle School and entry/step improvements at Three Bridges School. The Board is authorized to expend on such project and issue bonds for such project in an amount not to exceed \$1,780,000. The State has agreed to provide debt service aid in the amount of 40% of the "final eligible costs" of the school facilities project. All of the costs of the project are "final eligible costs".

2. The Board hereby approves and adopts the Proposal and, subject to the approval of the legal voters of the School District, hereby determines to carry out the same.

3. The Business Administrator/Board Secretary is hereby authorized and directed, in conjunction with Bond Counsel, to deliver a certified copy of this resolution and such other information as shall be necessary to comply with applicable provisions of the Education Law and Election Law, to the Executive Hunterdon County Superintendent of Schools, Hunterdon County Clerk, Hunterdon County Board of Elections, and to the Clerk of the Township of Readington, and to request such persons to undertake their respective functions under the Education Law and the Election Law, as applicable, in connection with the Election. The Business Administrator/Board Secretary is hereby authorized to amend the Proposal and the Explanatory Statement to conform same to statutory requirements.

4. The Board hereby acknowledges and confirms that, in accordance with the requirements of Sections 24-16 and 24-17 of the Education Law, a Supplemental Debt Statement has been prepared as of the date of this resolution by the Chief Financial Officers of the Township of Readington, giving effect to the proposed total authorization of School Bonds of the School District in the maximum amount provided for in the Proposal, and that such Supplemental Debt Statement has been filed in the offices of the Clerk of the Township of Readington, and in the office of the Business Administrator/Board Secretary prior to the adoption of this resolution. The Board hereby directs the Business Administrator/Board Secretary to cause such Supplemental Debt Statement to be filed in the office of the Director of the Division of Local Government Services, New Jersey Department of Community Affairs prior to the date of the Election.

5. The School Administration and such other officers, professionals and agents of the Board as are necessary, including Wilentz, Goldman & Spitzer, P.A., Bond Counsel and the Architect for the Project, are each hereby authorized and directed to perform such acts, execute such documents and do such things as are necessary and proper for the submission of the Proposal to the voters of the School District at the Election, including preparation and submission of all required applications for receipt of debt service aid.

6. The Board hereby (i) accepts the determination of Preliminary Eligible Costs as set forth in the letters of the New Jersey Department of Education (the "NJDOE Eligibility Letters"); (ii) elects to receive the State Share in the form of debt service aid; (iii) determines to construct the Project; (iv) agrees to locally fund any excess costs and (v) delegates the supervision of the Project to the Business Administrator/Board Secretary.

7. This resolution shall take effect immediately.
