Kindergarten and Grade 1 Bus Release Permission

1) Kindergarten and grade 1 students will not be left at a bus stop unless there is a designated responsible person there to meet them.

Kindergarten and grade 1 children who get off in the afternoon at stops with other elementary children must still be met by a responsible person.

2) If a responsible person is not there to meet him/her, the student will be transported back to the bus terminal. The driver shall contact the terminal by radio as soon as the decision is made to retain the student on the bus. Terminal personnel shall immediately initiate efforts to contact the parent/guardian. If unsuccessful, police will be contacted to assist. If a child is retained on the bus, the child must be returned to the terminal. A parent/guardian may not meet the bus at another stop and ask for release of the child.

3) The first instance of a return of a child to the terminal, in the absence of emergency circumstances which prevented the parent(s) or designated responsible person from being able to receive the student at the bus stop, shall generate a warning to parents. The second offense shall generate a written warning and the third and any subsequent offenses shall be referred to the Superintendent or his/her designee for appropriate action, which may include a suspension of bus privileges for up to ten days.

4) A parent/guardian may sign a waiver, which would allow the child to be dropped off at the designated bus stop even if there is no responsible person there to meet the bus.

I have reviewed a copy of the revised procedure for dropping Kindergarten and grade 1 students off at bus stops. I understand that the procedure directs that, unless a parent-designated responsible person is there to receive a Kindergarten or grade 1 student, the student will be transported back to the bus terminal and the parent/guardian/designee will have to pick the student up there.
