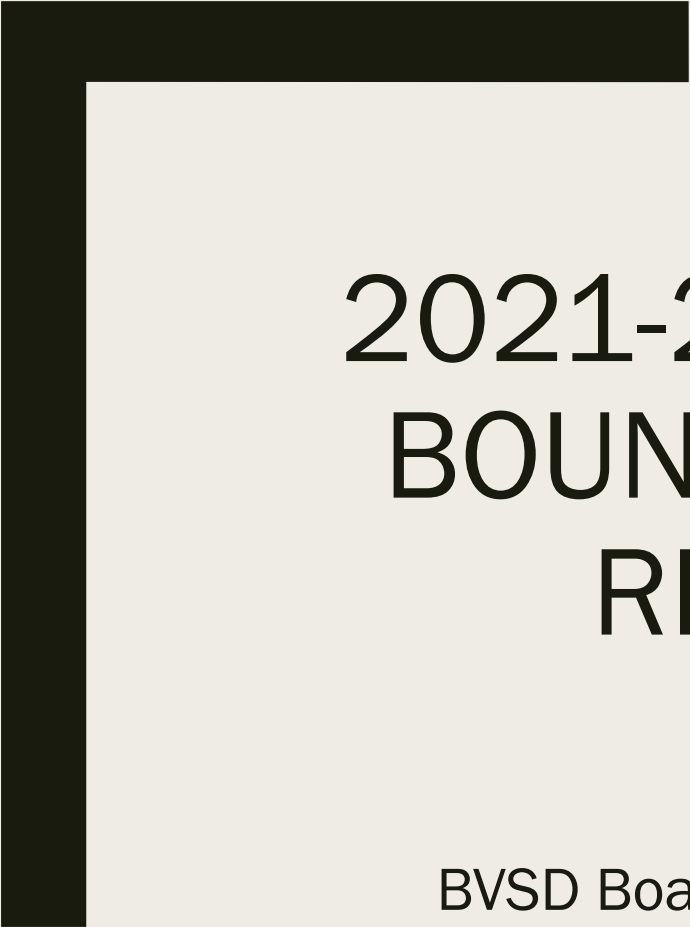

Navigating 2021-22 Elementary Student Enrollments Impacted by Boundary Changes

- All current 3rd Grade Students eligible to remain at current attendance center (FAE / VSE)
 - *Subject to In-district Open Enrollment Transportation Policy. No Transportation Services Provided.*
 - *Families are required to submit a request to remain at their current attendance center.*
- All other current Elementary Students may submit an In-district Open Enrollment Application
 - *Subject to In-district Open Enrollment Transportation Policy. Students not eligible for Transportation Services.*
 - *Subject to In-district Open Enrollment Policy - Classroom Capacity.*

Elementary English Language Learner Program

- BVSD will operate two (2) Elementary EL Programs
 - *Collaborated with Administration & EL Staff*
- Staffing for the English Language Learner Program will be provided at Brandon Elementary & the New Elementary (3401 S. Sparta Avenue)
- Rationale for the Program Location(s)
 - *Programming aligned to neighborhood school concept*
 - *Reduces likelihood of families declining services*
 - *Eliminates Transportation issues associated with moving students out of their assigned elementary boundary*

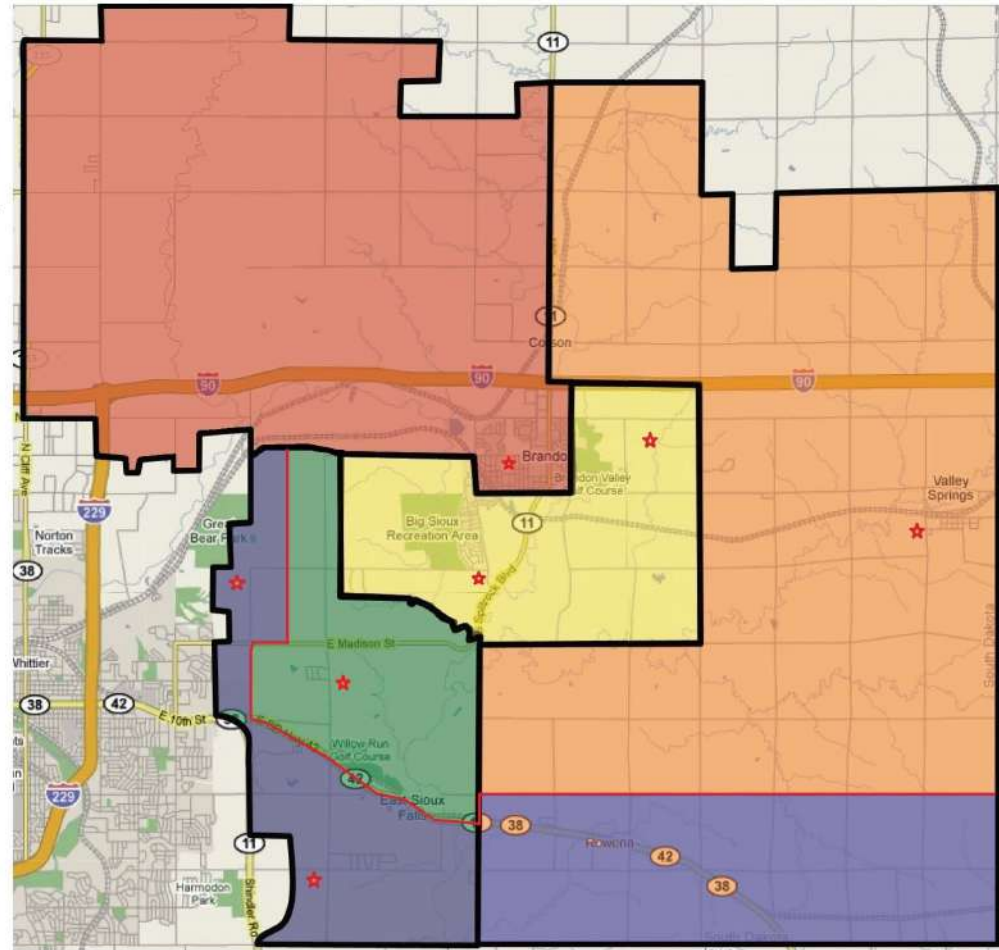

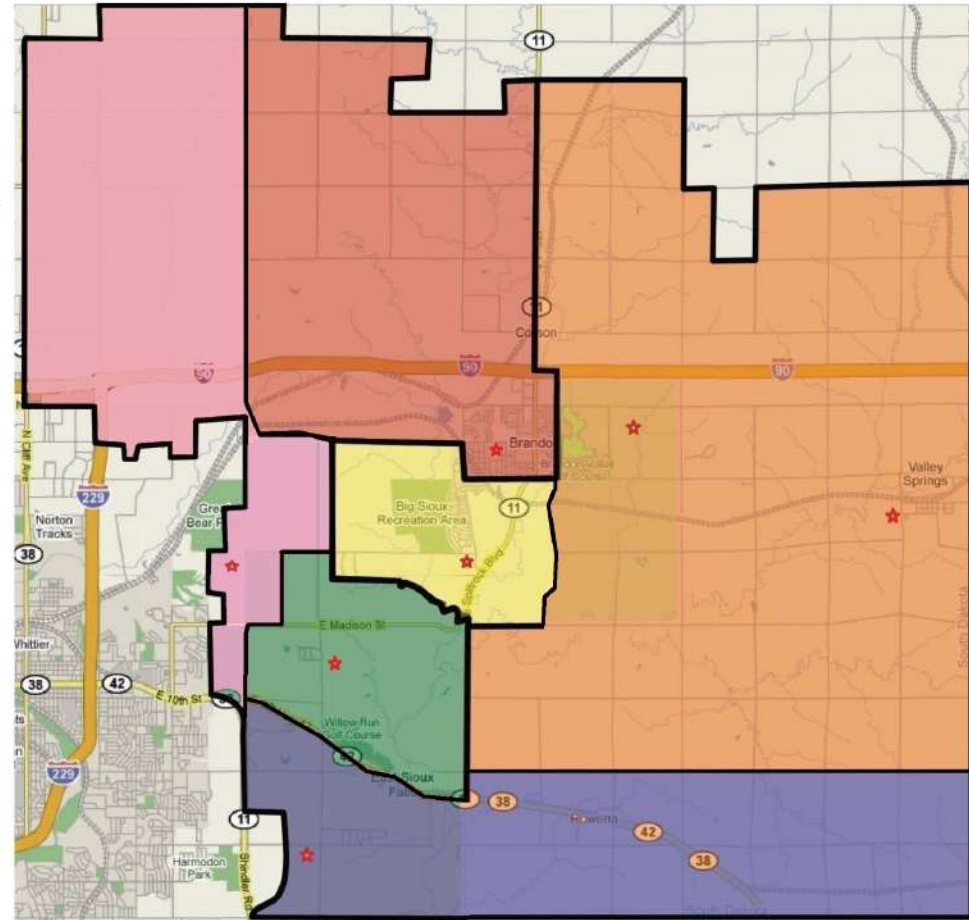
BV VISION 2040 Elementary Boundary Lines
