Foundation Mission: The Falcon Foundation is incorporated exclusively for charitable, educational or scientific purposes, particularly to support and enhance the educational and enrichment opportunities (social, cultural, and athletic) for all people in the Cornwall-Lebanon community.

Objective of Capital Projects Committee: To develop and maintain an inventory of capital projects that support the Foundation Mission Statement, involve the purchase of equipment and/or facilities within the Cornwall-Lebanon School District and are appropriate for individual or small group financial backing

Capital project characteristics:

- Must support the spirit of the Foundation's Mission Statement
- Satisfy needs not addressed by the School District budget
- ♦ Have estimated capital cost over \$1,000
- ♦ Design must be approved by the CLSD Administration
- ◆ Design must satisfy all Federal, State, Municipal, Board of Education and all other Agency regulations

Selection Process:

- ◆ Requests for Foundation Capital Projects can be initiated by anyone as long as the project involves equipment/ facilities within the CLSD.
- ♦ All requests will be reviewed by the CLSD Administration to determine if any items conflict with other planned facilities and to provide feedback to the Foundation on overall benefits to the District.
- ♦ All requests will then be reviewed by the Falcon Foundation Capital Projects Committee and recommendations for the Foundation Capital Projects Listing will be made to the Foundation Board.
- The Falcon Foundation Board will determine and approve the final project listing.

Evaluation of individual projects will be based on the following:

- ◆ The overall effect on the "educational and enrichment opportunities for all people in the Cornwall-Lebanon community"
- ♦ The size of the School District population affected by the project
- ♦ The agreement by the District to support and maintain the equipment/facility in future years
- ◆ Project creativity and uniqueness
