# Services for Young Adults:

#### Adulescent Partial Hospital Program at Benedictine Hospital

The Adolescent Partial Hospitalization Program (APHP) at Benedictine Hospital is a voluntary, intensive, short-term multi-disciplinary psychiatric treatment for adolescents ages 13-18 (18 year olds must be currently enrolled in a school program). Individuals who are admitted must be at risk of psychiatric hospitalization or be transitioning from an inpatient stay to the community. APHP is designed in compliance with NYSOMH and JCAHO standards to provide an alternative to inpatient treatment for persons with acute symptoms of a psychiatric or emotional illness. Applicants must meet criteria for medical necessity and be able to be safely treated with less than 24 hours daily care.

The major treatment focus is symptom reduction through medication management and the acquisition of coping skills through Dialectical Behavior Therapy. A psychiatrist directs the treatment team and mental health clinicians provide supportive individual therapy, group therapy, family therapy, case management, and advocacy. Academic tutoring is also offered in this program. The goal of the program is to lessen the difficulties individuals are presently experiencing while teaching coping skills to be used throughout life.

The program operates from 8:30am-2pm, Monday-Friday for program recipients. Staff is available on site from 8:00am-4pm Monday-Friday. When the program is closed, an on-call staff clinician is available via telephone.

# Teen WRAP: Wellness Recovery Action Planning

WRAP is a manualized group intervention that is recognized as an evidenced-based program by NREEP-SAMHSA. It is a process of self-exploration whereby individuals identify their vision of wellness, share effective coping skills, and set goals to achieve and maintain wellness. At the same time, individuals identify their thoughts, feelings, and behaviors in times of stress, distress, and crisis, creating action plans to better cope during such difficult times. This voluntary 6-week group for high school students will be offered in the fall of 2013; Dates and times to be determined. Registration is required.

# Adolescent Anger Management

The Anger Management for Teens Program is a FREE five week co-ed group for youth ages 12-18, who are having difficulty controlling their anger and it is causing problems at home or at school. # LifeSkills Training (LST)

LST is based on both the social influence and competence enhancement models of prevention for school age youth in grades 3-12. Consistent with this theoretical framework, LST addresses multiple risk and protective factors and teaches personal and social skills that build resilience and help youth navigate development tasks, including the skills necessary to understand and resist pro-drug influences. LST is designed to provide information relevant to the important life transitions that adolescents and young teens face, using culturally sensitive and developmentally and ageappropriate language and content. Separate programs are offered for youth in elementary school (grades 3-6), middle school (grades 6-9) and high school (grades 9-12).

#### GAP [Getting Ahead Program]

The GAP Program was designed to help Ulster County residents ages 16-21, with mental health issues. The program is designed to help you get your life in order. The GAP case worker can help you acquire housing if you need it, or help you maintain the housing you have. You will receive assistance in returning to an academic program if you are no longer in one, or help gaining employment if you need to. The program can help you manage your treatment, your medications if you're on them, and your appointments that you're responsible for. The GAP case worker will come to you. Services are available anywhere in Ulster County and are free of charge.

#### St. Cabrini Home, Inc.

St. Cabrini Home provides comprehensive care integrating clinical, educational, recreational, and socialization strategies for neglected, abused, and emotionally fragile adolescents, ages 12-21. Our group home services youngsters who do not require the intense structure of a residential placement but who are not ready to or are unable to live with family or on their own.

Our residential treatment center serves 86 adolescent girls who attend our on grounds school, the West Park Union Free School. Seven group homes provide family-like living arrangements for adolescent boys or girls in Poughkeepsie, Wappingers Falls, and Middletown, NY. St. Cabrini Home also provides substance abuse counseling and intervention to all students as needed in its programs through its OASAS licensed substance abuse clinic. The clinic, located on our West Park campus, provides initial assessments, regular counseling, groups, and referrals to inpatient substance abuse services as needed. We are sponsored by the Missionary Sisters of the Sacred Heart of Jesus.
