# **CMS Readiness Dashboard**

The data reflected in this Dashboard is to assess school readiness for EC, Pre-K, K-12.

## **Key Considerations for Metrics Dashboard:**

- The dashboard aims to provide a *general framework* for decision-making and recommendations related to in-person learning at the community, district, and school levels.
- The dashboard does NOT include *all* data points or additional factors that will be considered when making specific recommendations and decisions.
- This dashboard includes positive test data from both the county and families who self-report, and that information is cross-referenced. The county does not report to CMS instances when a CMS student tests positive if the student has not been attending school in-person for 14 days prior to testing positive, because there is not a risk of transmission in the school setting. The dashboard also does not include reporting on students who are enrolled in Full Remote Academy. Therefore, the number of positive cases reported should not be interpreted to represent the actual number of CMS students who have tested positive.

#### **Public Health Metrics**

Both metrics in green for >14 days: Consider/continue in-person learning at all schools in compliance with State's orders. One or both metrics in yellow (and no metrics in red) for > 14 days: Consider/continue in-person learning only for specific prioritized student populations in collaboration with Mecklenburg County Public Health (MCPH). One or more metrics in red for >14 days: Consider virtual learning for all students in collaboration with MCPH.

One or more metrics in red: Consider short-term classroom or school closure in collaboration with Mecklenburg County Public Health.

\* Number of schools are general guidelines and will vary based on the current number of schools at which in-person learning is occurring in addition to other relevant factors.

All metrics in green: Follow recommendations of Mecklenburg County Public Health. One or more metrics in yellow (and no metrics in red): District will consult with Mecklenburg County Public Health for recommendations re: short-term closures at the classroom(s) or school-level. One or more metrics in red: Consider short-term school closure in collaboration with Mecklenburg County Public Health. \*Numbers are only general guidelines and will vary based on the size of classes, number of individuals attending in-person at a school, and the results of case investigation and contact tracing processes, including specifically whether the cases attended while infectious and whether they are all linked to a specific exposure (e.g. same classroom).

All metrics in green: Schools ready to open/remain open. All metrics in yellow: Limited school openings based on readiness and prioritized student population. Metrics in red: Consider maintaining/return to virtual learning.
