


Guiding Principles



Overview, Review, and Availability of Plan

This plan has been developed to meet the requirements that have been established by the North Dakota Department of Public Instruction (NDDPI) following the American Rescue Plan (ARP) Act. The purpose of the ARP is to help safely reopen and sustain the safe operation of schools and address the impacts of COVID-19 on the nation's students. The ARP Plan for Central Cass has been developed in collaboration with students, staff, parents, and community members. Central Cass will continue to review this plan and seek public input, as required, at least every six months.



Health & Safety

The health and safety of our students and staff is the top priority. The health and safety procedures in this plan have been developed in consultation with local health officials, North Dakota Department of Health, and the Center for Disease Control.

Health & Safety Strategies

Wellness

- Students or staff who are sick should not attend school.
- Parents or caregivers will be asked to monitor children for signs of infectious illness.
- Any individual with a fever of 100 degrees or greater should not be present in school.

Cleaning & Disinfecting

- Staff will perform routine cleaning and disinfecting throughout the day.
- Nonirritating disinfectants will be used to avoid triggering breathing issues of students and staff.

Hand Hygiene

- Handwashing techniques will be taught and reinforced at all age levels.
- Handwashing with soap & water or hand sanitizer will be used when arriving at school, before
 and after eating, after using the bathroom and other times when it is the best interest of the
 students and staff.

Face Coverings

Masks may be recommended on campus according to the mitigation continuum.

Protecting Vulnerable Populations of Students & Staff

- We will consider the special health and education needs of students that are considered high-risk due to preexisting conditions that make them more vulnerable to severe illness due to COVID-19.
- These processes will be followed:
 - Students with current plans (IEP, 504, Health Plan, etc.) will be reviewed and updated to decrease the risk for exposure to COVID-19.
 - Empowering students/families and staff to self-identify high-risk for severe illness due to COVID-19 and consider requests for alternative learning plans or work re-assignments.

COVID Mitigation Continuum

Central Cass is committed to face-to-face instruction for the 2024-2025 school year. The Central Cass COVID Committee will utilize the following data points to move up and down the mitigation continuum to ensure we are doing our part to stop the spread of COVID-19:

- Number of positive COVID cases in students and staff.
- Availability of staff and substitute teachers.
- Number of absences in the district due to sickness and guarantine.

Normal

- Encourage the sick to remain home and monitor symptoms
- · Routine cleaning and disinfecting
- Promote and teach hand hygiene

Increased Mitigation

- COVID Team meets every other week to assess data
- Disinfecting procedures enhanced
- Mask recommendations implemented for cluster specific spread (classroom, buses, grade level, sports team, etc.)
- Temporary emergency distance learning for cluster specific spread (classroom, grade level, sports team etc.)
- No field trips, large-group gatherings, campus visitors, assemblies, etc.
- COVID Team meets every week to assess data


Board Approval Necessary


- Masks mandated for optional activities, and extra-curricular participants
- Masks mandated on campus
- Block Schedule/Reducing the mixing of student groups
- Spectator attendance restrictions for public activities and events.

Movement along the mitigation continuum will be announced through Swift and posted on the Central Cass website.

Educating Students in All Environments:

Central Cass has planned and prepared for the continued in person learning plan during the school year. A virtual learning option will **not** be available for the 2024-2025 school year.





Mental Health

Central Cass Public Schools will continue to prioritize the mental health needs of our students and staff during the 2024-2025 school year. Following the implementation of resources and services during the past school year, the Central Cass School Board will continue to ensure that school-based student behavioral health counseling will be available in each of our schools and all employees will have access to an Employee Assistance Program. These services are provided in partnership with The Village Family Service Center and School Based Counseling Services utilizing a wrap-around approach to meeting the needs of all students at Central Cass Schools.

Communications

We believe that communication between students, staff, parents, families, and community members are essential to the overall success of our school district. The ongoing collaboration among stakeholders of our school district will help strengthen student educational opportunities, experiences, and outcomes. Transportation

Central Cass School District will continue transportation services for students within our school district. As necessary, proper health and safety guidelines will be followed for any student riding a school bus.

Special Education

Central Cass School District will work in conjunction and collaboration with Rural Cass Special Education Unit to ensure that educational decisions for students with Individual Education Plans (IEPs) will be made on an individual basis and in compliance with the Individuals with Disabilities Education Act (IDEA) and ND Department of Instruction Office of Special Education guidelines. The learning environment, services, and accommodations for students with disabilities will be determined through the student's IEP team, including student's parent or guardian, school administration, and staff. The team will work together to develop plans that will ensure equitable and effective access to provide FAPE for students with special needs in all learning environments. Special education case managers will be the contact people for communication between each IEP student's parents/guardians and required team members, and will monitor the continuation of services and accommodations, whether they are provided virtually, in-person, or a combination model. The school district's Return to Learn Plan will focus on procedures for delivering education within the district, which will also apply to holding IEP team meetings and completing required special education procedures, while maintaining student and staff health and safety, according to the North Dakota K-12 Smart Restart guidelines.
