Course Syllabus

Course Description: *Students will apply knowledge learned in Criminal Justice I through practical scenarios and ethical examples involving crime scene investigation, criminal investigation, crisis intervention, and communication skills. Students will enhance their understanding of various crimes associated with narcotics and controlled substances and crimes against children. This course prepares students for careers as lawyers, forensic specialists, and law enforcement and corrections officers.*
