I. Call to Order

Mr. Huntress called the meeting to order at 7:00 PM and announced the meeting was being recorded.

III. Review/Approve Minutes

IV. Information/Discussion Items

- A. Carlisle School Committee Goals There was review of the 22-23 goals and activity related to each goal. At the next meeting there will be discussion regarding a spring community event.
- B. Student Reports Ziyao Ma was pleased to report that both the boys and girls basketball teams ended their seasons with winning records. The boys team was undefeated. The

Math Team is also at the top of their division. Their next meet is March 9. Rohan Danker noted that the 7th grade play is upcoming in March. School clubs have been active and the first Friday Night Live since the pandemic was held last week. Lily Bromley discussed activities related to the Multicultural Festival held in January. The Pride Club recently held a sale of handmade crafts. Student Council is planning upcoming pizza and bake sales and will donate funds raised to local charities. Students are busy with activities and academics prior to the school vacation. Grade 8 students will start course selection for high school in the next few days.

- C. CPS Health Curriculum Meghan Laughlin, CPS Health Teacher, reviewed the Health Curriculum for Middle School grades 5 through 8, showing examples of student activities and work. References in the presentation were from the National Health Education Standards. Ms. Laughlin noted that curriculum is updated as needed and cited the inclusion of the negative impacts of vaping over the past few years. Due to the pandemic, there has not been much coordination of curriculum with Concord Middle Schools but Ms. Laughlin is open to connecting with her colleagues in Concord. When a question arose regarding teaching about internet safety, Mr. O'Shea noted that this area is not addressed in the health curriculum but in the instruction surrounding digital citizenship. The committee addressed an email received advocating for the teaching of internet safety for elementary students.
- D. FY23 Budget Status Update Andy Paquette reviewed the budget update linked to the agenda and explained the changes reflect excpenses over the past few months. Adjustments to specific line items have been made but there was no change to the bottom line. Mr. Paquette highlighted changes to the line items related to transportation, utilities and maintenance of the building. A vote by the school committee to move funds will take place closer to the end of the school year.
- E. Looking at Shifts in Current Literacy Practices Mr. O'Shea stated that there are ongoing discussions regarding literacy practices in the district. The dialogue will continue during a March 1 meeting that will include community members. Adjustments will continue to be made to teaching practices, but it was noted that this is ongoing work. The committee will be provided an update later in the spring on this topic.
- F. Update on Capital Planning Process Work has been done to create a streamlined list of capital projects which includes more accurate cost estimates. This list has been shared with the Town Administration and the Finance Committee. Discussion of the funding mechanisms for projects included a possible warrant article as well as ARPA funding.

The Committee allowed public comment from Julie Viola of 588 Bedford Road, Carlisle, MA.

G. Telephone System Update - A vendor and product have been identified for school buildings as well as town buildings. An ARPA request for funding of the initial implementation of the system will be submitted in the near future. The hope is to schedule installation of the new system this summer.

VI. Superintendent's Update

On January 25 there was an early release day. During the school day and following dismissal there was a Multicultural Festival held in the Corey Dining Room area. Mr. O'Shea gave a shout out to Marie-Laure Rivier and the DEICAC for the successful event. The hope is to make this an annual event. CPS staff took part in professional development during the afternoon of January 25. There were three workshops that staff cycled through - Weaving DEI into Lessons & Learning, Navigating Unconscious Bias, and Leading Inside and Outside the Classroom. Six CPS staff members are currently taking a Skillful Teaching Course through the organization Research for Better Teaching. A book study for interested staff is currently underway for the book Seeing Gender. The Calendar Committee has met and will bring a calendar forward for School Committee review in March. Collaboration of School and Town Facilities is continuing. The William Be Yourself Challenge (WBYC) is hosting a lecture on Thursday, February 9 with Dr. Kelly McGonigal titled Be Yourself Through Movement. The WBYC is providing a portion of the funding for the 7th Grade Challenge Day planned for March. The Facilities Department is finally fully staffed with the addition of custodian Rick O'Neill. Mr. O'Shea enjoyed working with Juliette and Christian Martuscelli who each had the opportunity to be "Superintendent for the Day" after winning Bingo. The CEF and PTO are working together to put on the "Monte Carlisle" fundraiser scheduled for April 28 at the Westford Regency.

- A. Policy Subcommittee The subcommittee provided a list of policy recommendations that were reviewed previously in the meeting.
- B. Municipal Facilities Committee The committee continues to meet on a regular basis.
- C. Regional School Committee An FY24 budget was presented to the Concord Finance Committee. A presentation and deep dive into rankings was included in the last committee meeting. The 23-24 School Calendar was approved. CCHS is currently undergoing an overhaul of its daily schedule. There was a report on the recent Equity Audit done in the regional district. There is no expected increase in enrollment due to the new crisis housing put in place. Activities are scheduled for Black Excellence month in February.
- D. Special Education Subcommittee The subcommittee met on January 18, 2023 with the SEPAC to discuss the podcast "Sold A Story." The next meeting is scheduled for Wednesday, February 15, 2023.
- E. Meeting of Local School Committee Chairs Mr. Huntress attended a meeting of local school committee chairs and reported that he had some positive takeaways from the meeting. He will attend similar meetings in the coming weeks.
