INSTRUCTIONAL PROGRAMS

Calvert County Public Schools (CCPS) offers high school courses during the summer that are delivered in either an online, blended, or in a traditional setting.

<u>ONLINE COURSES</u> — (original and review credit) — CCPS offers online Financial Literacy, Foundations of Technology, Health, Music Appreciation, Spanish I, and Spanish II. Students are required to attend a synchronous orientation meeting utilizing Microsoft Teams on the first day of the course. Some courses may require students to meet with the instructor up to three additional times during the summer term. Students who request to take an online course must complete the Online Learning Interest Survey. <u>BLENDED REVIEW COURSES</u> – Blended courses are offered to students who did not successfully complete a course in which they had been enrolled during the regular school year. These courses utilize a blend of online learning and face-to-face instruction. The online portion of the course uses locally approved programs of study that offer diagnostic assessments to determine students' areas of weakness and provide targeted instruction.

<u>TRADITIONAL REVIEW COURSES</u> – These courses are offered to students who did not successfully complete a course in which they had been enrolled during the regular school year. Certified teachers provide targeted instruction related to students' specific learning deficits.

ADMISSIONS POLICY – These courses are available only to students who were enrolled in a high school course during the 2020-2021 school year. Public and private school students may attend CCPS summer school.

SUMMER SCHOOL COURSES

The CCPS high school summer school program for review courses will be held at the <u>Career & Technology Academy</u> <u>from July 12 – August 5, 2021</u>. These courses will be on <u>Monday – Thursday</u> for 3 hours and 45 minutes per course. Morning and afternoon sessions will be offered <u>if</u> there is sufficient enrollment. The sessions will be held from either 7:30 am to 11:15 am or 11:45 am to 3:30 pm.

The following courses will be offered:

ONLINE COURSES – These online courses may be taken for original or review credit. Online courses will begin on June 28, 2021 and will end on August 5. These courses require synchronous Teams meetings on the dates below. Tentative dates are listed but subject to change. Required virtual meetings will be communicated by the course instructor.

- Financial Literacy (must attend the first meeting and at least 2 others) 6/28⁺, 7/7, 7/14, 7/21, 7/28, 8/5]
- Foundations of Technology (must attend the first meeting and 2 others) 6/28⁺, 7/5, 7/12, 7/19, 7/26, 8/2]
- Health (must attend the first meeting and at least 4 others) 6/28⁺, 7/7, 7/14, 7/21, 7/28, 8/5]
- Music Appreciation (Rising seniors only) [must attend 6/28⁺]
- Spanish I [6 dates (must attend first and last dates) 6/28⁺ and 8/5⁺]
- Spanish II [6 dates (must attend first and last dates) 6/28⁺ and 8/5⁺]

REGISTRATION PROCEDURES

Online Course Registration: The process for Online Course registration begins by completing the Online Learning Interest Survey and the Summer School Registration Form. Refer to the table below for registration dates based on current 2020-21 grade level. Before registrations will be processed, you must complete the Online Learning Interest Survey, Summer School Registration Form, and payment must be submitted. Enrollment in online summer courses is limited and priority will be given to upperclassmen. Review Course Registration: The Summer School Registration Form for Blended and Traditional Review Courses may be obtained at each high school or found on the Calvertnet website https://www.calvertnet.k12.md.us/summerschool. Approval and submission of the Summer School Registration Form are required before registration may be completed. Printed Summer school registration forms should be submitted to the student's home school and students not enrolled in a CCPS high school may be returned in person or mailed to the summer school office at Career & Technology Academy 330 Dorsey Rd. Prince Frederick, MD 20678. Final class schedules for review courses are determined from the registration data available on June 21, 2021. Time limitations preclude the mailing of class acceptance notices to students. Class lists will be available by phone or in person at the summer school office at the Career & Technology Academy on July 8, 2021.

ATTENDANCE REQUIREMENTS

Since summer school lasts for only 16 days, participating students must maintain excellent attendance. **Credit will be denied if a student misses more than two class periods.** Students who cannot attend all classes should not enroll in credit courses. Students are also required to be on time for every class.

TUITION

There is no charge to enroll in a review course for Summer 2021. Students enrolling in an online course for original credit course would be charged \$275.00 for a half-credit course and \$325.00 for a full credit course (this includes a \$25.00 application fee). Courses for original credit are limited and priority of enrollment will be given to upperclassmen.

- CCPS Public School Student: Tuition is waived
- Private School/Non-County Resident: Review Credit \$250.00 Online Courses \$275.00/\$325.00

Full tuition for online courses must be paid by June 23, 2021. **Checks are to be made payable to Calvert County Public Schools**. If a student withdraws from a course after attending one or more classes, <u>no tuition will be refunded</u>. However, if a course is canceled, the full tuition will be refunded.

^{*}A non-resident is a person who is permanently located outside Calvert County during the regular academic year.

TRANSPORTATION

Calvert County Public Schools does not provide transportation during the summer term.
