January 10, 2023 Meeting Summary

On Tuesday, January 10, the Dyslexia Advisory Council convened via digital platform to discuss the following topics:

Council Background

Expectations of Council Members

Engrossed Second Substitute Senate Bill [6162](#) requires that Washington maintains an advisory council for the purposes of providing policy guidance with respect to early screening of literacy skills related to dyslexia and related instructional practices for students with dyslexia. Such an advisory panel shall consist of members appointed by the Office of Superintendent of Public Instruction (OSPI); and be comprised of individuals involved with issues surrounding dyslexia.

Expectations of Statute

In accordance with RCW [28A.320.260](#), LEAs must use Multi-Tiered System of Supports (MTSS) to:

- Screen students in grades K-2 for indications of below-grade level literacy development, including indications of / or areas of weakness associated with dyslexia.
- Provide evidence-based multisensory structured literacy interventions to students in grades K-2 who display indications of below-grade level literacy development, including indications of / or areas of weakness associated with dyslexia.
- Communicate and collaborate with parents and families about their student's screening results, intervention plan, and literacy progress.

RFQQ: RAN Screening Tools

After an overview presentation, DAC members worked in small groups to review a collection of materials related to the OSPI Request for Qualifications and Quotations (RFQQ) for the Rapid Automatized Naming (RAN) screening tools. The RAN screens

student's skill in rapidly identifying colors, numbers, letters, and familiar objects. The goal of OSPI is to publish a vetted list of approved academic screening tools for school districts to access. DAC Members provided written feedback for consideration prior to voting on approval for each vendor proposal.

Next steps in this process will be for OSPI to review results from the DAC member vote, the feedback from the small work team that reviewed the proposals, and the OSPI team will determine the finalized list of approved vendors to be added to the published list posted on the OSPI website by the end of January 2023. OSPI team will communicate externally the final outcome of this RFQQ process.

Upcoming Work

Save the Date information was provided regarding the Science of Reading virtual summit being held on May 11th and 12th. The summit is a virtual learning experience with literacy leaders to share the “Why and How of Equitable Structured Literacy”.
