Attendance records, agendas, and pertinent feedback will be provided to the District office as documentation of the process.
- Parents are involved in handbook meetings each year. Parental issues are their main focus. Handbook committees also include parent representation. A spring meeting will take place to review LEA Parental Involvement Policy.

- 2. The **School City of Hobart** will provide the following necessary coordination, technical assistance, and other support services to assist Title I, Part A schools in planning and implementing effective parental involvement activities to improve student academic achievement and school performance:

 - Ensure each school has developed jointly with parents a home/school compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement.
- 3. The **School City of Hobart** will build the schools' and parents' capacity for strong parental involvement in order to ensure effective involvement of parents. The District will support partnerships among the schools involved, parents, and the community. The purpose will be to assist in the improvement of student academic achievement through the following activities specifically described below:

B. The school district with the assistance of its schools, will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement.

The **School City of Hobart District Office** with the assistance of its schools, will provide funding for material and training to help parents work with their children throughout the year at each school. Each school will provide attendance records, agendas, and pertinent feedback to the district office each year. Topics may include but are not limited to:

Our Brickies From the Start/Parents as Teachers program has stressed the importance of parent involvement on a regular basis. Teachers are encouraged to recommend families to this program. Teachers go to parent educators for assistance.

To the extent feasible and appropriate, attendance records, agendas and an evaluation of these joint programs will be kept in the District office.

- 5. The **School City of Hobart** will take the following actions to conduct, with the involvement of parents, an annual spring evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I schools.
