# • Jointly Developed

These events include Title 1 programming, other areas of interest to our parents and families that support and engage them.

## Annual Title I Meeting

**Eastmont Elementary School** will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the school wide plan, and the school-parent compact. The annual Title 1 meeting was held virtual within the first two weeks of school in order to express the critical need for partnership between home and school from the start of the academic year. It was held in conjunction with the Eastmont Open House. All required paperwork was sent out and explained at this virtual meeting. The role of that parents can participate in as a school wide Title 1 school was reviewed. This meeting also shared critical information about the school's role in providing parents with information about meetings, assessments, and teacher qualifications.

## Communications

**Eastmont Elementary School** will take the following actions to provide parents of participating children the following:

- Timely information about the Title I programs,
- Flexible number of virtual meetings, such as meetings in the morning or evening, and may provide with Title I funds, transportation, home visits, as such services relate to parent and family engagement, and

Communication is delivered through a variety of media to ensure all families are informed of school events and important dates. Classroom communications are sent out virtually through many digital formats and by mail. Parent Square is used to send our information to all families via phone calls, texts, emails, and through the App. The Parent Organization (PTO) sends home information about events. School administration sends home a quarterly newsletter to keep families informed of school events and important dates.

## School-Parent Compact
